McDERMITT SURVEY 5.878 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 8, TOWN 5S RANGE 4E, NOBLE TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING A PART OF THOSE LANDS OWNED BY ROBERT McDERMITT (TRUSTEE) & LOIS McDERMITT (TRUSTEE) AS RECORDED IN DEED VOLUME 403 PAGE 18 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at an iron pin with O.D.O.T. cap found in a monument box found at the northeast corner of the northeast quarter of Section 8 and being at the intersection of the centerlines State Route 116 and Salem – Noble Road;

Thence, with the north line of the northeast quarter of Section 8 and the centerline of Salem – Noble Road, North 89°13'32" West, 1321.26 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with a new division line the following 3 lines:

- 1. South 01°19'31" West, 1602.77 feet to an iron pin set, passing for reference at 20.00 feet an iron pin set in the south right of way line of Salem Noble Road;
- 2. South 89°20'17" East, 598.20 feet to an iron pin set;
- 3. South 01°19'31" West, 394.68 feet to an iron pin set in the north line of a 30.064 acre tract of land owned by S. Seffernick as recorded in Official Record 258 Page 837;

Thence, with the north line of said 30.064 acre tract, North 89°20'17" West, 608.20 feet to the east line of a 66.265 acre tract of land owned by T. & S. Menchofer as recorded in Deed Volume 213 Page 566, passing for reference at 608.00 feet a 1\2 inch iron pin found;

Thence, with the east lines of said 66.265 acre tract, a 9.930 acre tract owned by L. & M. Chaney as recorded in Official Record 79 Page 424, a 25.005 acres tract of land owned by L. & S. Clausing as recorded in Deed Volume 250 Page 722 and a 1.500 acre tract of land owned by N. McDermitt as recorded in Official Record 513, Page 1650, North 01°19'31" East, 1997.47 feet to a railroad spike found in the north line of a the northeast quarter of Section 8 and the centerline of Salem – Noble Road, passing for reference at 1977.47 to the south right of way line of Salem – Noble Road, witnessing at North 32°33' 36" East 0.17 feet to a 5/8 inch iron pin found and witnessing at North 54°29'20" East, 0.54 feet to a iron pipe found;

Thence, with the north line of the northeast quarter of Section 8 and the centerline of Salem – Noble Road, South 89°13'32" East, 10.00 feet to the **True Point of Beginning**, containing 5.878 acres more or less of which 0.005 acres lie within the right of way of Salem – Nobel Road and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings are based upon Ohio State Plane North Zone 3401 NAD 83. The survey records referenced are all recorded in the Shelby County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988".
