


Thence S.00°16'40"W. a distance of 1,039.43 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the South right-of-way line of County Road 160:

Thence S.50°00'14"W. along the Northerly right-of-way line of the R.J. Corman Railroad, a distance of 935.23 feet to an iron pin set;

Thence N.00°16'40"E. a distance of 1,646.66 feet to a Mag Nail set, passing thru an iron pin set for reference at 1,621.66 feet in the South right-of-way line of County Road 160;

Thence S.89°30'32"E. along the centerline of County Road 160 and the North line of the Northwest Fractional Quarter of Section 30, a distance of 713.55 feet to the Monument Box which was the true PLACE OF BEGINNING.

Thence N.89°30'32"W. along the centerline of County Road 160 and the North line of the Northwest Quarter of Section 30, Washington Township, a distance of 713.55 feet to a Mag Nail set which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°16'40"W. a distance of 1,646.66 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the South right-of-way line of County Road 160;

Thence S.50°00'14"W. along the Northerly right-of-way line of the R.J. Corman Railroad, a distance of 1,324.18 feet to an iron pin set;
