

SURVEYOR'S DESCRIPTION

Being Part of Outlot 1 of Mckee and Scott's Outlots in the City of St. Marys, also part of the northwest corner of Section 3, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio, and more particularly described as follows:

Commencing for reference at a P.K. nail (found) where the centerline of the 66 foot right-of-way of Defiance Street intersects the centerline of the 66 foot right-of-way of Madison Street; thence, with said centerline of Madison Street extended at South 89°50'20" West for a distance of eight and 00/100 (8.00) feet to a point; thence, North 00°00'00" East for a distance of five hundred sixty- two and 55/100 (562.55) feet to a point where the south line of the former Toledo & Ohio Central Railway intersects the centerline of the 50 foot right-of-way of Defiance Street; thence, North 89°59'35" East along aforesaid south line of the former railway, for a distance of one hundred sixty-four and 87/100 (164.87) feet, to a point, said point being the **POINT OF BEGINNING** for the tract herein described;

Thence, continuing along aforesaid south line of the former railway North 89°59'35" East for a distance of three hundred seventy-two and 25/100 (372.25) feet to a point;

Thence, South 00°03'19" West along the east line of said Outlot 1, for a distance of one hundred seventy and 07/100 (170.07) feet to a 5/8" re-rod with cap (set);

Thence, North 89°49'27" West along the north line of the North Addition to the City of St. Marys (passing through a 5/8" re-rod found on the east right-of-way of Lynn Street at a distance of one hundred forty-three and 94/100 (143.94) feet, also passing through a 5/8" re-rod found on the west right-of-way of Lynn Street, at a distance of two hundred nine and 89/100 (209.89) feet) for a total distance of three hundred forty-three and 95/100 (343.95) feet to a 3/4" iron pipe (found);

Thence, North 00°00'00" East for a distance of seventy-one and 81/100 (71.81) feet to a 3/4" iron pipe (found);

Thence, North 89°51'00" West for a distance of twenty-eight and 14/100 (28.14) feet to a 3/4" iron pipe (found);

Thence, North 00°00'00" East (passing through a 3/4" iron pipe (found) at a distance of fifty-six and 58/100 (56.58) feet) for a total distance of ninety-seven and 09/100 (97.09) feet to the **POINT OF BEGINNING**; containing therein 1.402 acres of land, more or less.
