Thence along the south line of the S ½ of the NE ¼ of Section 29, N 89°-42'-35" W a distance of 1,836.73 feet to a set 5/8 inch iron pin capped, passing a set 5/8 inch iron pin capped at 25.00 feet marking the west right-of-way line of Moulton-Fort Amanda Road (CR 91);
