

TOSTRICK SURVEY 1.483 ACRES

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 2, TOWN 7S RANGE 6E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY JOHN AND KAREN TOSTRICK AS RECORDED IN DEED VOLUME 228 PAGE 895 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at an Auglaize County monument box in the north line of the southeast quarter of Section 2 and the centerlines of Kettler Road and New Bremen New Knoxville Road;

Thence, with the centerline of New Bremen New Knoxville Road, the following 3 courses;

- 1. South 35°22'04" West, 469.08 feet;
- 2. With a curve to the right having a Delta Angle of 10°24'33", Radius of 1495.80 feet, Arc Length of 271.75 feet, Chord Bearing South 39°32'39" West, 271.38 feet;
- 3. South 43°43'14" West, 269.88 feet, to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the centerline of New Bremen New Knoxville Road, South 43°43'14" West, 195.37 feet to a Mag Nail set;

Thence, with a spiral to the right having a Length of Spiral of 98.84 feet, Radius of Curve 407.70 feet, Tangent of 174.19 feet and Long Chord Bearing South 49°21'26" West, 98.29 feet to a Mag Nail set;

Thence, with a curve to the right with a Delta Angle of 12°17'52, Radius of 407.70 feet, Arc Length of 87.51 feet with a Long Chord Bearing South 57°16'52" West, 87.34 feet to a Mag Nail set;

Thence, with the east line of the Miami Erie Canal, North 00°48'23" East, 444.48 feet, to an iron pin set, passing for reference at, 141.25 feet an iron pin set in the north right of way line of New Bremen New Knoxville Road;

Thence, with a new division line the following 3 courses;

- 1. South 80°21'30" East, 166.72 feet to an iron pin set;
- 2. South 15°54'37" West 87.85 feet to an iron pin set;
- 3. South 59°43'14" East 158.12 feet to the **True Point of Beginning** containing 1.483 acre more or less of which 0.348 acre lie within the right of way of New Bremen New Knoxville Road, passing for reference at 132.42 feet an iron pin set in the north right of way line of New Bremen New Knoxville Road, and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings listed above are based upon Ohio State Plane Grid Coordinates, North Zone 3401, NAD 83, distances shown are U.S. Survey feet, Ground. The survey records referenced are all filed in the Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988".

10' WATERLINE EASEMENT

Beginning for reference at an iron pin at the northwest corner of a 1.483 acre tract of land owned by John and Karen Tostrick as per Deed Volume 228, Page 895;

Thence, with the north line of said 1.483 acre tract, South 80°21'30" East, 46.87 feet to the **True Point of Beginning** of a 10 foot waterline easement herein described;

Thence, continuing with said north line of 1.483 acre tract, South 80°21'30" East, 10.06 feet;

Thence, with the east line of a 10 foot easement, South 15°43'25" West, 63.00 feet;

Thence, with the north line of a 10 foot easement, South 47°29'08" East, 111.01 feet;

Thence, with the east line of a 10 foot easement, South 29°16'55" West, 10.27 feet;

Thence, with the south line of a 10 foot easement, North 47°29'08" West, 119.52 feet;

Thence, with the west line of a 10 foot easement, North 15°43'25" East, 68.08 feet, to the Point of Beginning;

Bearings listed above are based upon Ohio State Plane Grid Coordinates, North Zone 3401, NAD 83, distances shown are U.S. Survey feet, Ground. The survey records referenced are all filed in the Auglaize County Recorder's Office.

60' GEO THERMAL EASEMENT

Commencing at an iron pin at the northwest corner of a 1.483 acre tract of land owned by John and Karen Tostrick as per Deed Volume 228, Page 895, said iron pin marking the **Point of Beginning** of a 60 foot Geo Thermal easement herein described;

Thence, with the east line of the Miami Erie canal and the west line of a 29.01 acre tract of land owned by John and Karen Tostrick as per Deed Volume 228, Page 895, North 00°48'23" East, 99.76 feet;

Thence, with the north line of a 60 foot easement, South 89°11'37" East, 60.00 feet;

Thence, with the east line of a 60 foot easement, South 00°48'23" West, 109.09 feet;

Thence, with the north line of said 1.483 acre trat, North 80°21'30" West, 60.72 feet to the Point of Beginning;

Bearings listed above are based upon Ohio State Plane Grid Coordinates, North Zone 3401, NAD 83, distances shown are U.S. Survey feet, Ground. The survey records referenced are all filed in the Auglaize County Recorder's Office.

DRIVE EASEMENT

Commencing at a Mag Nail at the northeast corner of a 1.483 acre tract of land owned by John and Karen Tostrick as per Deed Volume 228, Page 895, and the centerline of New Bremen New Knoxville Road, said Mag Nail marking the **Point of Beginning** of a drive easement herein described;

Thence, with the centerline of New Bremen New Knoxville Road, South 43°43'14" West, 12.34 feet;

Thence, with the south line of a drive easement, North 59°43'14" West, 155.26 feet;

Thence, with the west line of a drive easement, North 11°52'02" West, 105.93 feet;

Thence, with the north line of said 1.483 acre tract, South 80°21'30" East, 16.12 feet;

Thence, with the east line of a drive easement, South 11°52'02" East, 77.93 feet:

Thence, with the east line of said 1.483 acre tract, South 15°54'37" West, 14.91 feet;

Thence, with the north line of said 1.483 acre tract, South 59°43'14" East, 158.12 feet to the Point of Beginning;
