




CONRADI SURVEY 5.001 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 13, TOWN 7S, RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY KAREN CONRADI AS RECORDED IN OFFICIAL RECORD 558 PAGE 625 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at a Mag Spike set over a railroad spike found at the northwest corner of the northeast quarter of Section 13 and the centerline of State Route 274, said Mag Spike marking the **Point of Beginning** of the tract herein described;

Thence, with the north line of the northeast quarter of Section 13 and the centerline of State Route 274, South 87°46'00" East, 573.28 feet to a Mag Nail set;

Thence, with a new division line the following 2 courses;

1. South 00°50'16" West, 379.78 feet to an iron pin set, passing for reference at 30.00 feet an iron pin set in the south right of way line of State Route 274;

2. North 87°46'00" West, 573.28 feet to an iron pin set in the east line of a 5.600 acre tract of land owned by Karen Conradi as per Official Record 558, Page 625;

Thence, with the east line of said 5.600 acre tract, North 00°50'16" East, 379.78 feet to the **Point of Beginning**, containing 5.001 acres more or less of which 0.395 acres lie within the rights of way of State Route 274, passing for reference at feet the south right of way line of State Route 274 witnessing at said point at South 82°35'38" West, 2.49 feet a bent 5/8 inch iron pin (bent) found, being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings are based upon Ohio State Plane Grid Coordinates North Zone 3401, NAD 83, Distances shown are U.S. Survey Feet Ground. The deed records referenced are all recorded in the Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988".
