



SURVEYOR'S DESCRIPTION

scale:

Being a part of the southeast quarter of Section 7, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Deed Volume 305, Page 901 and more particularly described as follows:

Commencing for reference at a railroad spike (found) at the northeast corner of Section 7 and the centerline intersection of Buckland-Holden Road and State Route 501; thence, S 00° 35′ 07″ W along the east line of the northeast quarter of Section 7, and the legal centerline of State Route 501 for a distance of 2660.62 feet to the East quarter corner of Section 7; thence, continuing along the aforesaid legal centerline and east line of the southeast quarter of Section 7 for a distance of 408.71 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for tract herein described;

thence, continuing along the said centerline and east line, S 00° 35′ 07″ E for a distance of 165.00 feet to a mag-nail (set);

thence, N 89° 24′ 53″ W (passing through a 5/8″ re-rod w/cap set for reference at a distance of 30.00 feet, and passing the west right-of-way line of State Route 501 at a distance of 40.00 feet) for the total distance of 210.00 feet to a 5/8″ re-rod w/cap (set);

thence, N 00° 35' 07" E for a distance of 165.00 feet to a 5/8" re-rod w/cap (set);

thence, S 89° 24′ 53″ E passing through the west right-of-way line of State Route 501 at a distance of 170.00 feet, and a 5/8″ re-rod w/cap set for reference at a distance of 180.00 feet) for a total distance of 210.00 feet to the **POINT OF BEGINNING**, containing therein **0.794 acres**, of which 0.151 acres is road right-of-way.

SAVE AND EXCEPT; an easement for drain tile located in the southeast part of the above described subject tract measuring 140.00 feet east and west, and 15.00 feet north & south, the southeast corner of this easement is one in the same as the southeast corner of the above described subject tract, containing therein 2,100 square feet.
