





KOHLER DESCRIPTION 26.061 ACRE

The following described tract of land is part of the Northwest Fractional Quarter of Section 2, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a point in the centerline of U.S. Route 33, being Sta. 110+04.32 at the Northwest corner of the Northwest Fractional Quarter of Section 2, Pusheta Township;

Thence S.89°40'27"E. along the North line of the Northwest Quarter of Section 2 and the centerline of U.S. Route 33, a distance of 50.00 feet to a point which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.89°40'27"E. along the above described line, a distance of 979.60 feet to a point; Thence S.00°50'15"W. a distance of 1,314.72 feet to an iron pin found, passing thru an iron pin found at 30.00 feet in the South right-of-way line of U.S. Route 33;

Thence N.89°40'27"W a distance of 1,029.60 feet to an iron pin found;

Thence N.00°54'06"E., along the West line of the Northwest Fractional Quarter of Section 2, a distance of 253.30 feet to an iron pin found, passing thru an iron pin set at 149.44 feet;

Thence N.89°11'30"E. a distance of 550.52 feet to an iron pin found from a previous survey; Thence N.00°48'25"E. a distance of 288.00 feet to an iron pin found from a previous survey;

Thence N.81°14'17"W. a distance of 504.88 feet to an iron pin found from a previous survey;

Thence N.00°48'25"E. a distance of 688.45 feet to an point, passing thru an iron pin found at 658.45 feet in the South right-of-way line of U.S. Route 33, said point was the true PLACE OF BEGINNING.

Containing in all 26.061 Acres of which 0.675 Acre is subject to easement for highway purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 504, page 76. This plat is recorded in Survey Book "R", page 360 in the Auglaize County Engineer's Office. Basis of bearing is the North line of the Northwest Fractional Quarter of Section 2, Pusheta Township and the centerline of U.S. Route 33 as S.89°40'27"E. (Auglaize County GPS Survey Data). This description is based on an actual field survey, performed by me, John W. Jauert in May 2013.
