

## WESSEL SURVEY 1.248 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 12, TOWN 6S, RANGE 4E, ST MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY REBECCA, JENNIFER, AND SANDRA WESSEL AS RECORDED IN OFFICAL RECORD 476 PAGE 972 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at a iron pin at the northwest corner of the northeast quarter of Section 12;

Thence, with the west line of the northeast quarter of Section 12, South 01°07'14" West, 1725.26 feet to the south line of a 13 acre tract owned by Rebecca, Jennifer, and Sandra Wessel as recorded in Official Record 476 Page 972;

Thence, with the south line of said 13 acre tract, South 89°29'35" East, 1245.06 feet, to an iron pin set, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, with a new division line the following 4 courses;

- 1. North 03°14'26" West, 65.27 feet to an iron pin set;
- 2. North 13°47'39" West, 80.90 feet to an iron pin set;
- 3. North 01°09'44" West, 86.17 feet to an iron pin set;
- 4. North 89°44'48" East, 204.18 feet to an Mag Nail set, passing for reference at 172.00 feet an iron pin set in the west right of way line of State Route 29;

Thence, with the centerline of State Route 29 with a curve to the right having a Delta Angle of 01°57'27", Radius of 1432.40 feet, Arc Length 48.94 feet and a Chord Bearing of South 20°16'12" East, 48.94 feet to a Mag Nail set;

Thence, with the centerline of State Route 29, South 19°14'58" East, 198.29 feet to a Mag Nail set;

Thence, with the south line of said 13 acre tract, North 89°29'35" West 261.79 feet to the **True Point of Beginning**, passing for reference at 31.88 feet an iron pin set in the west right of way line of State Route 29, containing 1.248 acres more or less of which 0.170 acres lies in the right of way of State Route 29, and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings listed above are based upon Ohio State Plane North Zone, 3401, NAD 83, Grid Distances shown are Ground. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988".
