



## SURVEYOR'S DESCRIPTION

scale:

Being parts of Lots 1, 8 and 14 of the Reuben Comer plat in the unincorporated Village of Santa Fe, Section 25, T-6-S, R-7-E, Clay Township, Auglaize County, Ohio as evidenced by Official Record 369, Page 599 and more particularly described as fellows:

Commencing for reference at a monument box (found) at the intersection of the east line of the northeast corner of Section 25 (centerline County Highway 17) with the centerline of State Route 720 (former De Loss Pike); thence, along the centerline of State Route 720 bearing N 63° 14′ 41″ W for a distance of 327.67 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, S 01° 09′ 11″ E (along a line which was determined by "PROPERTY LINE AGREEMENT", signed and acknowledged on July 29, 2013 and attached hereto), passing through a 5/8″ re-rod w/ca (set) on the south right-of-way line at a distance of 20.52 feet, for a total distance of 258.26 feet to a 5/8″ re-rod w/cap (set);

thence, N 89° 37' 03" W for a distance of 88.50 feet to a 5/8" re-rod w/cap

(set); thence, S 00° 02′ 54″ W for a distance of 210.77 feet to a 5/8″ re-rod w/cap (set):

thence, N 89° 37′ 16″ W for a distance of 70.00 feet to a 5/8″ re-rod w/cap (found);

thence, N 00° 04' 21" E for a distance of 380.50 feet to a 5/8" re-rod w/cap

thence, S 89° 37′ 14″ E for a distance of 69.86 feet to a 5/8″ re-rod w/cap (set);

thence, N 00° 02′ 54″ E (passing through a 5/8″ re-rod w/cap set on the south right-of-way line of State Route 720 at a distance of 109.46 feet) for a total distance of 129.76 feet to a mag-nail (set) on the centerline of State Route 720;

thence, S 63° 14′ 41″ E for a distance of 93.00 feet to the **POINT OF BEGINNING**, containing therein 1.159 acres, of which 0.039 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is assumed. Prepared by James M. ## PROPERTY LINE AGREEMENT

THIS AGREEMENT, made July 29, 2013, between Alphonse J. Meyer, 23934 State Route 720 and Anna M. Davis, 23962 State Route 720, both of the unincorporated Village of Santa Fe, Clay Township, Auglaize County, Ohio, who are adjoining landowners of properties separated by a common boundary line and described as "East line of Lot 8" and also the "West line of Lot 9", and projecting south to the south line of Lot 14,both of the Reuben Comer Plat to Santa Fe as recorded in the public records of Auglaize County, Ohio located in Wapakoneta, Ohio.

**IN CONSIDERATION** of the permanent resolution of their mutual boundaries the parties, being uncertain of and in dispute about the location of their common boundary line and desirous of establishing that line of ownership conclusively so that each party will be able to make improvements and or maintain their respective properties, do agree on and fix the common boundary line between the respective properties on attached Plat of Survey.
