

Wendell & Delores Schultz 2 of 2 November 15, 2013

PARCEL 1 LEGAL DESCRIPTION

Being part of parcel #H23-028-002-02 as described in OR Volume 420, Page 434 of the Auglaize County Official Record of Deeds. Situated in the SW ¼ of Section 28, T-5-S, R-4-E, Noble Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at an iron bar in a monument box found marking the northwest corner of said SW ¼ of Section 28, Noble Township;

Thence along the West line of said SW ¼ of Section 28, Noble Township, also being the centerline of Lambert Road, S 01°-07'-15" W (basis of bearing) a distance of 293.89 feet to a railroad spike found;

thence along the north line of a 30.761 acre tract as described in said OR Volume 420, Page 434, S 89°-21'-13" E a distance of 2,138.64 feet to a set mag nail over a railroad spike on the centerline of State Route 116;

thence along said centerline of State Route 116, S 19°-35'-02" E a distance of 277.14 feet to a set mag nail over a railroad spike;

thence along the north line of a 5.001 acre tract as described in OR Volume 178, Page 707 conveyed to Wendell & Delores Schultz, N 89°-21'-13" W a distance of 737.05 feet to a set 5/8 inch iron pin capped, also being the POINT OF BEGINNING for the tract of land herein described;

thence continuing along said north line of a 5.001 acre tract as described in OR Volume 178, Page 707 conveyed to Wendell & Delores Schultz, N 89°-21'-13" W a distance of 236.00 feet to a 5/8 inch iron bar (Geeslin PS #5372) found;

thence N 00°-38'-47" E a distance of 148.00 feet to a set 5/8 inch iron pin capped;

thence parallel with said north line of a 5.001 acre tract as described in OR Volume 178, Page 707 conveyed to Wendell & Delores Schultz, S 89°-21'-13" E a distance of 236.00 feet to a set 5/8 inch iron pin capped;

thence S 00°-38'-47" W a distance of 148,00 feet to the POINT OF BEGINNING.

The above described parcel contains 0.802 acres of land, subject to all legal highways and easements of record at the time of recording of this instrument.

Basis of bearing for this legal description assumes the West line of the SW ¼ of Section 28, also being the centerline of Lambert Road as S 01°-07'-15" W per Auglaize County GPS Survey.

This legal description and accompanying plat represents an actual boundary survey performed by Eric R. Pfenning, PS # 8129 on November 15, 2013. All set 5/8 inch iron pin are marked with an orange plastic cap stamped "Angle Right S-8129".
