

VAN HORN SURVEY 1.932 ACRE TRACT

The following described tract of land is part of the Southeast Quarter of Section 20, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio, being part of Parcel No. N41-020-007-00 and is more particularly described as follows:

Commencing at an iron pin with O.D.O.T. cap found at the Southeast corner of the Southeast Quarter of Section 20, Wayne Township and in the intersection of the centerlines of County Road 160 (Focht Road) and State Route 196;

Thence N.00°50'29"E. along the centerline of State Route 196 and the East line of the Southeast Quarter of Section 20, Wayne Township, a distance of 1,540.75 feet to a Mag Nail set which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.89°24'18"W. a distance of 190.00 feet to an iron pin set, passing thru an iron set at 30.00 feet in the West right-of-way line of State Route196;

Thence N.00°50'29"E., parallel to the centerline of State Route 196 and the East line of the Southeast Quarter of said Section 20, a distance of 443.00 feet to an iron pin set;

Thence S.89°24'18"E. a distance of 190.00 feet to a P.K. Nail found, passing thru an iron pin set for reference at 160.00 feet in the West right-of-way line of State Route196;

Thence S.00°50'29"W. along the centerline of State Route 196 and the East line of the Southeast Quarter of Section 20, a distance of 443.00 feet to the Mag Nail which was the true PLACE OF BEGINNING.

Containing in all 1.932 Acre of which 0.305 Acre has been dedicated for highway purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 44, page 408. The above description and plat are recorded in Survey Book "R", Page 530, in the Auglaize County Engineer's Office. Basis of bearing is holding the East line of the Southeast Quarter of Section 20 and the centerline of State Route 196 as N.00°50'29"E. per the Auglaize County Global Positioning Survey.
