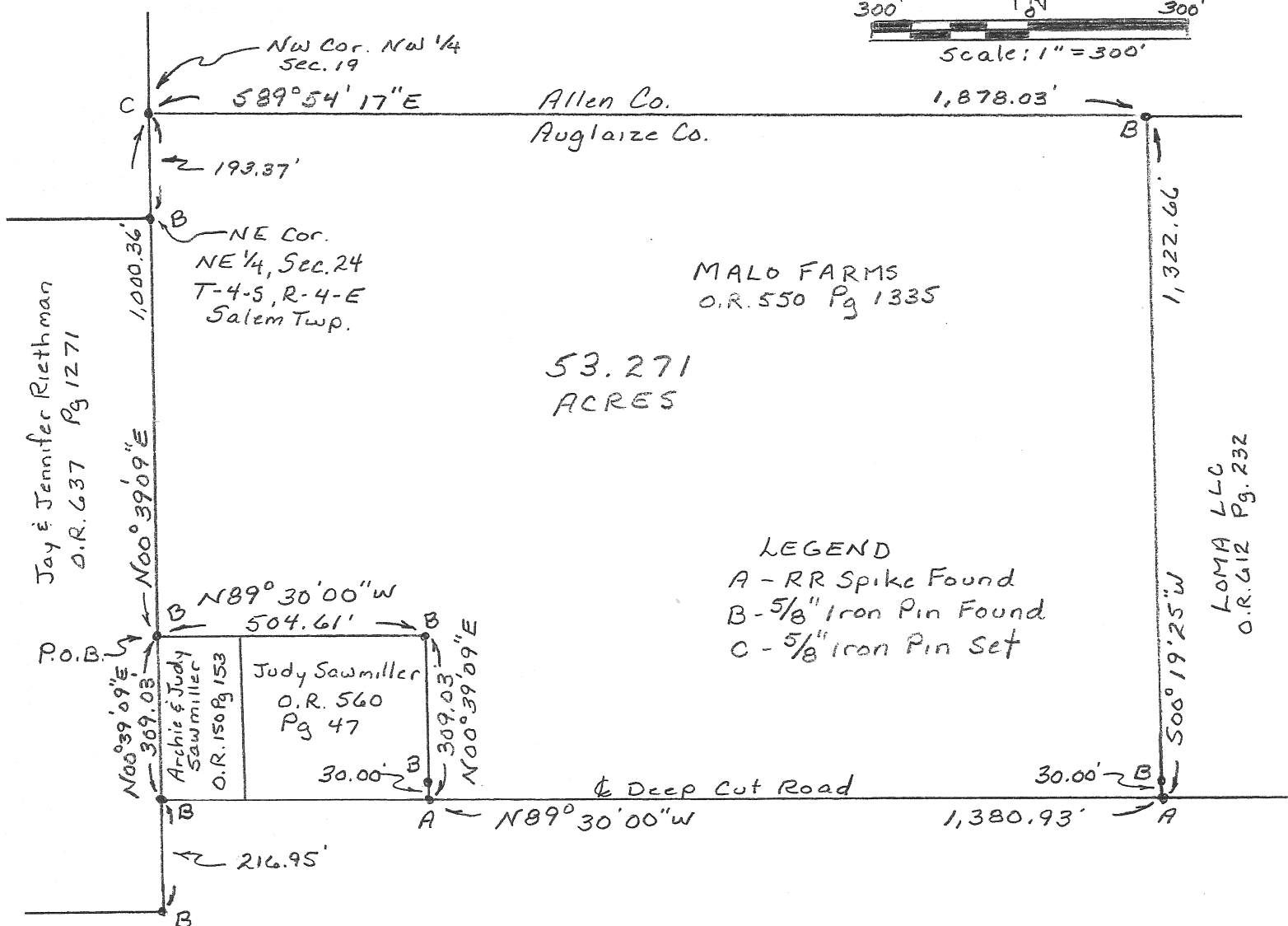

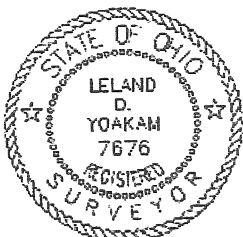

The following described parcel of land is situated in the northwest quarter of Section 19, Township 4 South, Range 5 East, Logan Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a 5/8 inch iron pin (found) marking the intersection of the centerline of Deep Cut Road with the west line of the northwest quarter of Section 19;

thence with the west line of said northwest quarter N 00° 39' 09" E, a distance of 309.03 feet to a 5/8 inch iron pin (found) at the POINT OF BEGINNING for the parcel to be described;

thence continuing with the west line of the northwest quarter of Section 19, N 00° 39' 09" E, a distance of 1,000.36 feet to a 5/8 inch iron pin (set) at the northwest corner of the northwest quarter of Section 19 passing at 806.99 feet a 5/8 inch iron pin (found);

thence S 89° 54' 17" E, a distance of 1,878.03 feet to a 5/8 inch iron pin (found);


thence S 00° 19' 25" W, a distance of 1,322.66 feet to a railroad spike (found) in the centerline of Deep Cut Road passing at 1,292.66 feet a 5/8 inch iron pin (found);

thence with the centerline of Deep Cut Road N 89° 30' 00" W, a distance of 1,380.93 feet to a railroad spike (found);

thence N 00° 39' 09" E, a distance of 309.03 feet to a 5/8 inch iron pin (found) passing at 30.00 feet a 5/8 inch iron pin (found);

thence N 89° 30' 00" W, a distance of 504.61 feet to the POINT OF BEGINNING containing 53.271 acres, more or less, subject to all legal highways and easements of record. This description is based on a field survey performed in March, 2014 and was prepared by Leland D. Yoakam L.S. No. 7676. All markers are accurate as to material and location and are in place.
