



SITUATE IN THE SOUTHWEST QUARTER OF SECTION 23, TOWN 6S, RANGE 6E, WASHINGTON TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY JOHN AND MARY HEMMERT AS RECORDED IN OFFICAL RECORD 164 PAGE 359 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Commencing at a Mag Nail found at the southeast corner of the southwest quarter of Section 23and the centerlines of State Route 219, said Mag Nail marking the **Point of Beginning** of the tract herein described;

Thence, with the south line of the southwest quarter of Section 23 and the centerline of State Route 219, North 89°33'17" West, 185.50 feet to a Mag Spike set;

Thence, with a new division line the following 2 courses;

- 1. North 00°26'43" East, 364.71 feet to an iron pin set, passing for reference at 25.00 feet an iron pin set in the north right of way line of State Route 219;
- 2. North 89°33'17" West, 150.35 feet to an iron pin set;

Thence, with the east line of a 27.00 acre tract of land owned by J. Leffel as recorded in Official Record 611, Page 2337, North 00°26'43" East, 283.52 feet to an iron pin set;

Thence, with the south line of said 27.00 acre tract, South 89°33'17' East, 344.32 feet to an iron pin set in the east line of the southwest quarter of Section 23 and the west line of a 16.488 acre tract of land owned by J. & M. Dillon as recorded in Official Record 70, Page 128;

Thence, with the west line of said 16.488 acre and the west line of a 1.01 acre tract of land owned by L. & J. Dicke as recorded in Official Record 357, Page 301, South 01°11'38" West 648.28 feet to the **True Point of Beginning**, passing for reference at 623.28 feet an iron pin set in the north right of way line of State Route 219, containing 3.802 acres more or less of which 0.107 acres lies in the right of way of State Route 219, and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings listed above are based upon Ohio State Plane North Zone, 3401, NAD 83, Grid Distances shown are Ground. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988".
