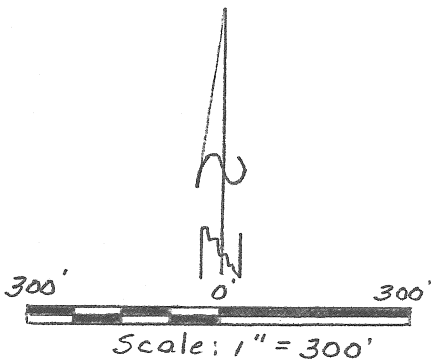


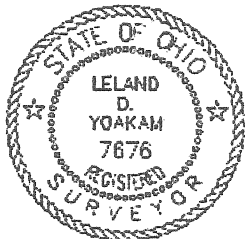
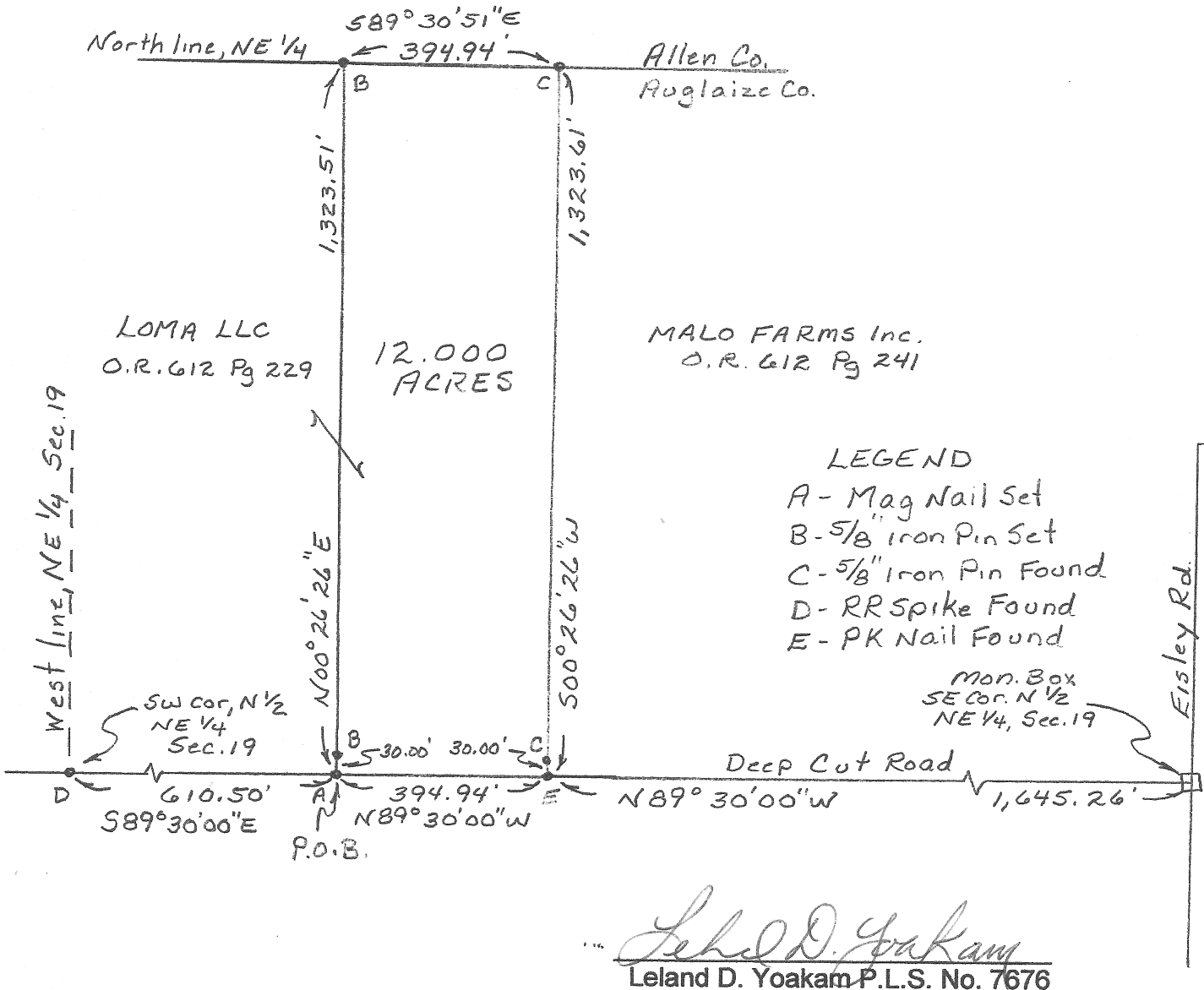

The following described parcel of land is situated in the northeast quarter of Section 19, Township 4 South, Range 5 East, Logan Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a railroad spike (found) marking the southwest corner of the north half of the northeast quarter of Section 19 also being the centerline of Deep Cut Road;

thence with the centerline of Deep Cut Road, S 89° 30' 00" E, a distance of 610.50 feet to a mag nail (set) at the POINT OF BEGINNING for the parcel to be described;


thence N 00° 26' 26" E, a distance of 1,323.51 feet to a 5/8 inch iron pin (set) passing at 30.00 feet a 5/8 inch iron pin (set);

thence S 89° 30' 51" E, a distance of 394.94 feet to a 5/8 inch iron pin (found);

thence S 00° 26' 26" W, a distance of 1,323.61 feet to a PK nail (found) in the centerline of Deep Cut Road passing at 1,293.61 feet a 5/8 inch iron pin (found);

thence with the centerline of Deep Cut Road, N 89° 30' 00" W, a distance of 394.94 feet to the POINT OF BEGINNING containing 12.000 acres, more or less, subject to all legal highways and easements of record. This description is based on a field survey performed in March, 2014 and was prepared by Leland D. Yoakam L.S. No. 7676. All markers are accurate as to material and location and are in place.
