

Beginning for reference at a 1 in iron pin found in a monument box at the northeast corner of the southeast quarter of Section 18 and the centerline of Glynwood-New Knoxville Road;

Thence, with the east line of the southeast quarter of Section 18 and the centerline of Glynwood – New Knoxville Road, South 01°04'38" West, 655.67 feet to a Gin Spindle found, said Gin Spindle marking the **True Point of Beginning** of the tract herein described;

Thence, with the east line of the southeast quarter of Section 18 and the centerline of Glynwood-New Knoxville Road, South 01°04'38" West, 493.27 feet to a Mag Nail set;

Thence, with a new division line, North 88°55'22" West, 2632.77 feet to an iron pin set, passing for reference at 25.00 feet an iron pin set in the west right of way line of Glynwood – New Knoxville Road;

Thence, with the east line of the southwest quarter of Section 18 and the east line of a 182.297 acre tract of land owned by N. & L. Howell as recorded in Official Record 588 Page 2479, North 00°39'07" East, 1119.33 feet to an iron pin found with Lock Two cap at the northwest corner of the southeast quarter of Section 18;

Thence, with the south line of the northeast quarter of Section 18 and the south line of said 182.297 acre tract and the south line of a 20.00 acre tract of land owned by G. & K. Ramga and C. & C. Sidney as recorded in Official Record 558, Page 2479 and Deed Volume 246 Page 323, South 89°33'56" East, 1315.57 feet to the northwest corner of a 17.873 acre tract of land owned by G. & K. Lambert as recorded in Official Record 557 Page 1575, witnessing at North 02°07'29" East, 0.24 feet an iron pin with "Kent" cap found;

Thence, with the west line of said 17.873 acre tract, South 00°58'20" West, 656.06 feet to an iron pin (disturbed) found with "Kent" cap found;

Knatz as recorded in Official Record 582 Page 351, South 89°34'59" East, 1324.48 to the **True Point of Beginning**, containing 48.706 acres more of less of which 0.283 acre lie within the right of way of Glynwood-New Knoxville Road, passing for reference at 977.29 feet an5 \ 8 inch iron pin (bent) found and at 1299.48 feet an iron pin with "Kent" cap found, and being subject to all legal rights of way, easements agreements and restrictions of record,


