



SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 1, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio as evidenced by Official Record Volume 436, Page 2537 (Parcel #K3100100500) and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of Section 1; thence, N 89° 45′ 20″ E along the south line of the southwest quarter of Section 1 for a distance of 280.77 feet to a 5/8″ re-rod w/cap (found), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, N 01° 04' 36'' W (passing through an iron pipe found at a distance of 138.08 feet) for a total distance of 168.08 feet to the center of a creek;

thence, S 72° 40' 58'' E along the aforesaid centerline for a distance of 216.95 feet to a point;

thence, leaving said creek S 00° 46′ 50″ W (passing through a 5/8″ re-rod w/cap set for reference at a distance of 29.96 feet) for a total distance of 102.62 feet to a 5/8″ re-rod w/cap (set) on the south line of the southwest quarter of Section 1;

thence, S 89° 45′ 20″ W along the aforesaid south line for a distance of 202.56 feet to the **POINT OF BEGINNING**, containing therein 0.636 acres. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per "Moran Survey" performed by John Jauert, PS 6920 dated May 3, 1985. Being a part of the southwest quarter of Section 1, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio as evidenced by Official Record Volume 436, Page 2537 (Parcel #K3100100500) and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of Section 1; thence, N 89° 45′ 20″ E along the south line of the southwest quarter of Section 1 for a distance of 483.33 feet to a 5/8″ re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, N 00° 46′ 50″ E (passing through a 5/8″ re-rod w/cap set for reference at a distance of 72.66 feet) for a total distance of 102.62 feet to the center of a creek;

thence, S 72° 40′ 58″ E along the aforesaid centerline for a distanced of 5.89 feet to a point;

Thence, continuing along the aforesaid centerline S 83° 30′ 12″ E for a distance of 126.36 feet to a point;

thence, leaving said creek S 00° 36′ 08″ W (passing through a 5/8″ re-rod w/cap found for reference at a distance of 30.00 feet) for a total distance of 86.00 feet to a 5/8″ re-rod w/cap (found) on the south line of the southwest quarter of Section 1;

thence, S 89° 45′ 20″ W along the aforesaid south line for a distance of 131.67 feet to the **POINT OF BEGINNING**, containing therein 0.283 acres. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per "Moran Survey" performed by John Jauert, PS 6920 dated May 3, 1985.
