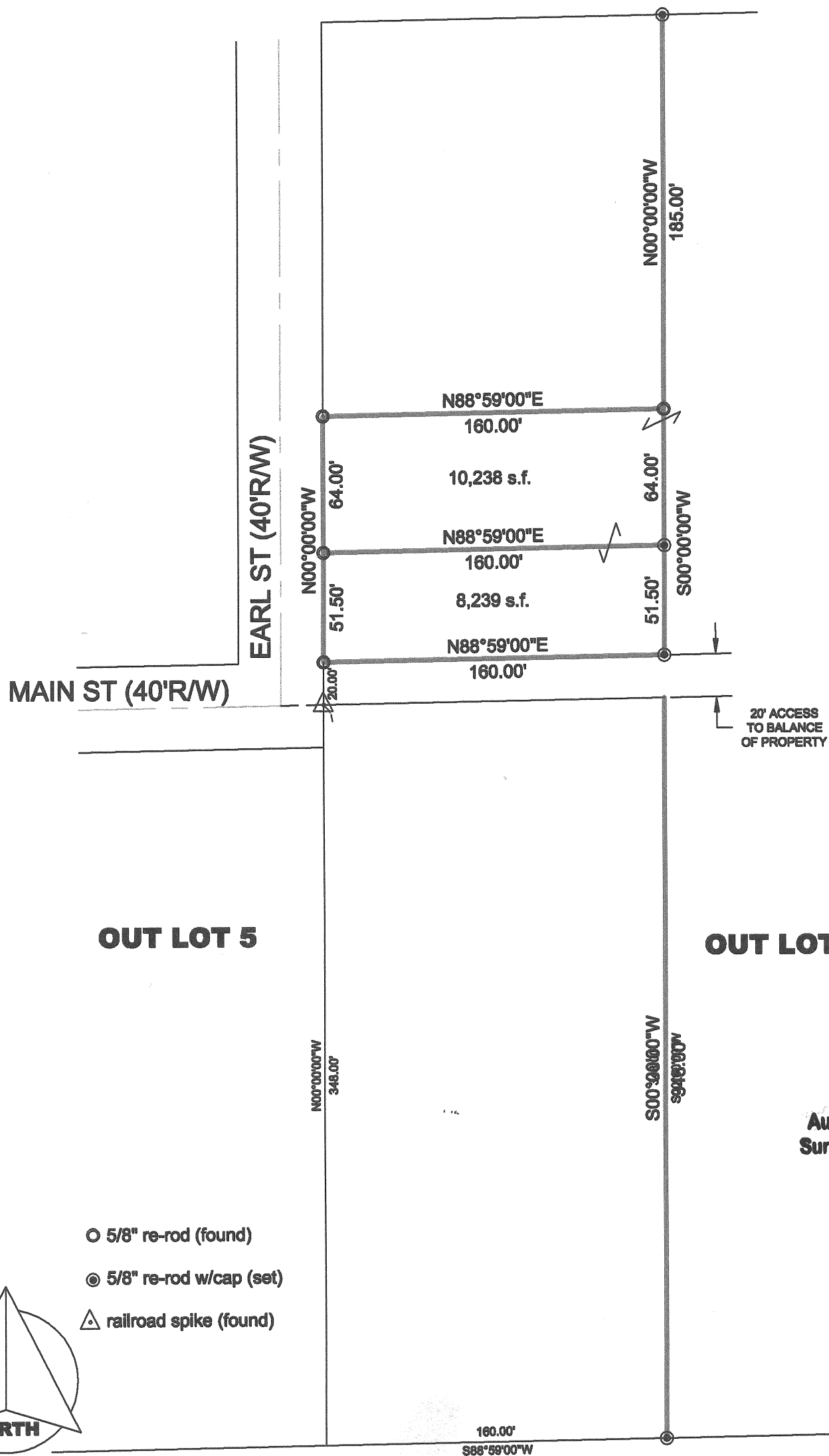
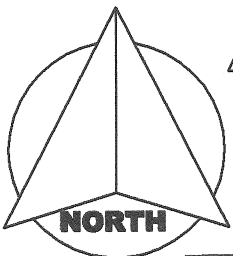

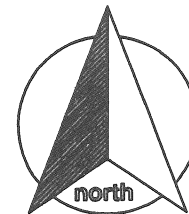

Commencing for reference at a railroad spike (found) at the intersection of the centerline of Main Street with the east right-of-way line of Earl Street; thence, N 00° 00' 00" W along the aforesaid east right-of-way line for a distance of 71.50 feet to a 5/8" re-rod (found), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

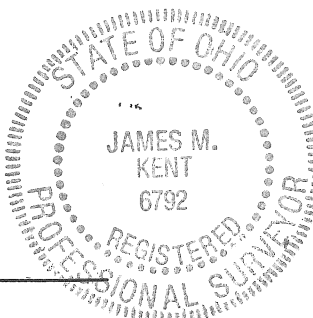
thence, continuing N 00° 00' 00" W along the aforesaid right-of-way line for a distance of 64.00 feet to a 5/8" re-rod (found);

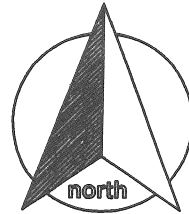

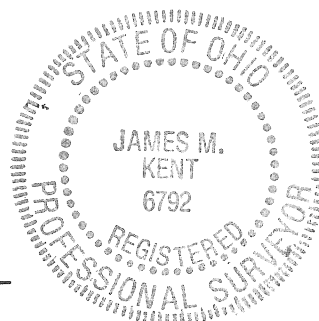
