





SITUATE IN THE VILLAGE OF NEW BREMEN, NORTHEAST QUARTER OF SECTION 15 TOWN 7S RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF LOT 382, OF KOOPS SOUTH ADDITION SUBDIVISION OWNED BY MARK & CHARLOTTE SCHWABERO AS RECORDED IN OFFICIAL RECORD 609 PAGE 2107 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at an iron pin found with "Lock Two" cap at the southwest corner of Lot 382 in Koop & Boesch South Addition as recorded in Plat Cabinet C, Slide 23, said corner marking the **Point of Beginning**, of the tract herein described;

Thence, with the west line of Lot 382 and the east line of a 16.50 foot alley, North 05°04'08" West, 71.09 feet to a Mag Nail set;

Thence, with a new division line and the south line of a tract of land owned by W. Miller as recorded in Official Record 629 Page 1983, South 88°40'25" East, 46.54 feet to a Mag Nail found, passing for reference at 40.11 feet a Mag Nail found;

Thence, with the west line of a tract of land owned by L. Koenig as recorded in Official Record 628 Page 1482, South 04°15'30" East, 70.99 feet to an iron pin found with "Lock Two" cap;

Thence, with the north line of Lot 6 of the Sunny Side Subdivision, North 88°40'25" West, 45.53 feet to the **Point of Beginning** containing 0.075 acre more or less and being subject to all legal rights of way, easements agreements and restrictions of record,

Bearings are based on Ohio State Plane grid coordinates, North Zone 3401 NAD 83. Distances shown are U.S. Survey feet Ground. The survey records referenced are all recorded in the Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988".
