

Surveyor's Description of 2.3695 Acre Parcel

The following described parcel of land is a part of the Northwest Quarter of Section 11, Wayne Township, Town-5-South, Range-8-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box (found) situated at the Southwest corner of the Northwest Quarter of said Section 11, Wayne Township, and the PLACE OF BEGINNING;

Thence with a bearing of N. 01°-07'-57" E. along the West line of the Northwest Quarter of said Section 11, Wayne Township, and the centerline of Worrel Road (Township Road #291), for a distance of 503.53 feet to a Mag Nail (set);

Thence with a bearing of S. 89°-35'-21" E. and parallel with the South line of the Northwest Quarter of said Section 11, Wayne Township, for a distance of 205.00 feet to an Iron Pin (set), and passing thru an Iron Pin (set) for reference at a distance of 20.00 feet;

Thence with a bearing of S. 01°-07'-57" W. and parallel with the West line of the Northwest Quarter of said Section 11, Wayne Township, and the centerline of Worrel Road (Township Road #291), for a distance of 503.53 feet to an Iron Pin (set);

Thence with a bearing of N. 89°-35'-21" W. along the South line of the Northwest Quarter of said Section 11, Wayne Township, for a distance of 205.00 feet to a Monument Box (found), and passing thru an Iron Pin (set) for reference at a distance of 185.00 feet, said Monument Box (found) being the original PLACE OF BEGINNING.

Containing in all 2.3695 Acres of land, of which, 0.231 Acre being previously dedicated for highway purposes. The above described tract of land is subject to any or all legal easements, reservations, or restrictions of record upon said premises.

The basis of bearings used for this description were determined from the Auglaize County Engineer's Global Positioning Survey.
