


Surveyor's Description of 0.037 Acre Parcel

The following described parcel of land is a part of the Northeast Quarter of Section 35, Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a P.K. Nail (found) at the intersection of County Road 33A and Kettlersville Road (Township Road #111);

Thence with a bearing of N. 81°-33'-00" E. along the centerline of County Road 33A for a distance of 2,114.04 feet to a P.I. point of said centerline of County Road 33A;

Thence with a bearing of N. 81°-45'-00" E. and continuing along the centerline of County Road 33A, for a distance of 660.45 feet to a point located at centerline station 643+00 of said County Road 33A;

Thence with a bearing of N. 08°-15'-00" W. for a distance of 67.00 feet to an Iron Pin (found) on the Northerly limited access right-of-way line of said County Road 33A;

Thence with a bearing of N. 82°-32'-00" E. along the Northerly limited access right-of-way line of said County Road 33A, for a distance of 145.66 feet to an Iron Pin (set);

Thence with a bearing of N. 07°-28'-00" W. a distance of 157.80 feet to an Iron Pipe (found) and the PLACE OF BEGINNING;

Thence with a bearing of S. 81° -18'-00'' W. for a distance of 113.11 feet to an Iron Pin (found);

Thence with a bearing of N. 64°-10'-00" W. for a distance of 50.71 feet to an Iron Pin (found);

Thence with a bearing of S. 88°-11'-10" E. for a distance of 157.53 feet to an Iron Pipe (found) and the original PLACE OF BEGINNING.

Containing in all 0.037 Acres of land (1625.77 square feet) subject to any or all legal easements, reservations, or restrictions of record upon said premises.


The basis of bearings used for this description were determined from previous surveys of record and the existing legal description of grantee's deed of record (Deed Volume OR 635, page 2076-79).
