Commencing at a Monument box found in the centerline of Township Road 111 (Kettlersville Road) and at the Southeast corner of the Northeast Quarter of Section 34, Moulton Township;

Thence N.01°00'36"E. along the East line of the Northeast Quarter of Section 34 and the centerline of Township Road 111, a distance of 28.84 feet to a P.K Nail found which is the PLACE OF BEGINNING for the tract of lane herein described;

Thence S.81°24'36"W. a distance of 169.30 feet to an iron pin set, passing thru an iron pin found at 20.28 feet in the former West right-of-way line of Township Road 111;

Thence N.89°28'10"W. a distance of 281.10 feet to an iron pin set;

Thence N.00°54'48"E. a distance of 97.59 feet to an iron pin found;

Thence S.88°59'24"E. along the South line of the S. & T. Burden property as described in Deed Volume O.R. 38, page 556 and O.R. 43, page 851, a distance of 448.19 feet to a P.K. Nail found, passing thru an iron pin found at 428.19 feet in the original West right-of-way line of Township Road 111;

Thence S.01°00'36"W. along the centerline of Township Road 111 and the East line of the Northeast Quarter of said Section 34, a distance of 67.00 feet to the P.K. Nail which was the true PLACE OF BEGINNING.

Containing in all 0.933 Acre of which 0.078 Acre has been dedicated for highway purposes.
