SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 22, Town-6-South, Range-6-East, Pusheta Township, Auglaize County, Ohio as evidenced by Official Record Volume 282, Page 482 and a part of Parcel No. I2422100101 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southwest quarter of Section 22; thence, along the south line of the southwest quarter and the legal centerline of Santa Fe - New Knoxville Road N 86° 55' 00" W for a distance of 1219.70 feet to a mag-nail (set) at the centerline intersection of Santa Fe - New Knoxville Road and Rupert Road; thence N 26° 46' 37" E along the legal centerline of Rupert Road for a distance of 554.23 to a mag-nail (set) said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid legal centerline N 26° 46' 37" E for a distance of 47.07 feet to a mag-nail (set);

thence, N 28° 48' 37" E along the aforesaid centerline for a distance of 405.40 feet to a mag-nail (set);

thence, N 27° 55' 37" E along the aforesaid centerline for a distance of 313.24 feet to a mag-nail (set);

thence, S 02° 47' 40" W (passing through the east right-of-way line of Rupert Road at a distance of 47.09 feet and a 5/8" re-rod w/cap set for reference at a distance of 79.82 feet) for a total distance of 692.58 feet to a 5/8" re-rod w/cap (set);


thence, N 86° 55' 00" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 285.64 feet and the east right-of-way line of Rupert Road at a distance of 308.15 feet) for a total distance of 329.99 feet to the **POINT OF BEGINNING** containing therein 2.612 acres, of which 0.340 acres is road right-of-way. 

SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 22, Town-6-South, Range-6-East, Pusheta Township, Auglaize County, Ohio as evidenced by Official Record Volume 282, Page 482 and a part of Parcel No. I2422100101 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southwest quarter of Section 22 and the legal centerline of Santa Fe - New Knoxville Road; thence, N 86° 55' 00" W along the south line of the southwest quarter and the aforesaid legal centerline for a distance of 664.44 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;


thence, continuing N 86° 55' 00" W along the aforesaid south line and legal centerline for a distance of 555.26 feet to a mag-nail (set) at the centerline intersection of Santa Fe - New Knoxville Road and Rupert Road;


thence, N 26° 46' 37" E along the legal centerline of Rupert Road for a distance of 554.23 feet to a mag-nail (set);
