## **SURVEYOR'S DESCRIPTION**

Being a part of the northwest quarter of Section 3, Town-6-South, Range-5-East, Washington Township, Auglaize County, Ohio as evidenced by Official Record Volume 643, Page 9 and part of Parcel No. M3700300200 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the southwest quarter of Section 3 and the centerline intersection of Washington Pike and Bay Road; thence, N 02º 07' 57" E along the west line of the aforesaid southwest quarter and the legal centerline of Bay Road for a distance of 2656.37 feet to a mag-nail (set); thence, N 02° 07′ 57" E and continuing along the aforesaid west line and legal centerline (and passing through the west quarter corner at a distance of 16.00 feet) for a total distance of 41.99 feet to a mag-nail (set); thence, N 74° 48′ 05″ E for a distance of 283.71 feet to a 5/8" re-rod w/cap (set); thence, N 18° 46' 01" E for a distance of 445.06 feet to a 5/8" re-rod w/cap (set); thence, N 67° 59' 01" E for a distance of 75.00 feet to a 5/8" re-rod w/cap (set); thence, S 85° 13′ 59" E for a distance of 172.00 feet to a point (said point being referenced by a 5/8" re-rod w/cap bearing S 74° 06' 58" W of and 39.93 feet from said point; thence, N 79° 13' 01" E for a distance of 395.00 feet to a 5/8" re-rod w/cap (set); thence, N 56° 19' 01" E for a distance of 275.00 feet to a 5/8" re-rod w/cap (set); thence, N 85° 41' 01" E for a distance of 270.00 feet to a 5/8" re-rod w/cap (set); thence, S 82° 06′ 59" E for a distance of 104.29 feet to a point in the centerline of Clear Creek and the POINT OF BEGINNING for the tract herein described;

thence, continuing along the centerline of Clear Creek N 84° 50′ 04″ E for a distance of 395.09 feet to a point;

thence, S 88° 09' 13" E for a distance of 185.64 feet to a point;

thence, leaving said creek S 55° 01′ 01″ W for a distance of 80.00 feet to a 5/8″ rerod w/cap (set);

thence, N 89° 28′ 59" W for a distance of 269.50 feet to a 5/8" re-rod w/cap (set);

thence, N 82° 06′ 59″ W for a distance of 341.71 feet to the **POINT OF BEGINNING** containing therein 0.847 acres.
