SITUATE IN THE NORTHWEST QUARTER OF SECTION 22, TOWN 6S RANGE 4E, ST MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING A PART OF THOSE LANDS OWNED BY DEBORAH & RONALD WILKER (TRUSTEES) AS RECORDED IN OFFICIAL RECORD 620 PAGE 1030 & OFFICIAL RECORD 637 PAGE 2635 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at an 1 inch iron pin found in a monument box at the southwest corner of the northwest quarter of Section 22 and being in the centerline of Dowty Road;

Thence, with the south line of northwest quarter of Section 22 and the centerline of Dowty Road, South 88°50'30" East, 582.96 feet;

Thence, with the east line of a 4.504 acre tract of land owned by R. & K. Hubbell as recorded in Official Record 445 Page 961, North 01°32'31" East, 401.90 feet to an iron pin with "Geeslin" cap found, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the east line of said 4.504 acre tract, North 01°32'31" East, 259.28 feet to an iron pin found with "Geeslin" cap found;

Thence, with a new division line, South 88°50'30" East, 163.00 feet to an iron pin set;

Thence, with a new division line, South 01°32'31" West, 259.28 feet to an iron pin set at the northeast corner of a 1.500 acre tract of land owned by C. & R. Lauth as recorded in Official Record 453 Page 2184;

Thence, with the north line of said 1.500 acre tract, North 88°50'30" West, 163.00 to the **True Point of Beginning** containing 0.970 acre more of less and being subject to all legal rights of ways easements, agreements and restrictions of record;

Basis of bearings is based on the State of Ohio VRS Network, NAD 83, 2011 Adj. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
