



SURVEYOR'S DESCRIPTION

scale:

Being a part of the northwest quarter of Section 7, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio as evidenced by Official Record Volume 401, Page 166 and a part of Parcel No. N4100700101 and more particularly described as follows:

Commencing for reference at a monument box (found) at the north quarter corner of Section 7 and the legal centerline of Buckland-Holden Road; thence, N 89° 08′ 44″ W along the north line of the northwest quarter of Section 7 and the aforesaid legal centerline for a distance of 1954.04 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, S 02° 43′ 31″ W (passing through a 5/8″ re-rod w/cap set on the south right-of-way line of Buckland-Holden Road at a distance of 25.00 feet) for a total distance of 437.87 feet to a 5/8″ re-rod w/cap (set);

thence, N 89° 10′ 14″ W (passing through a 5/8″ re-rod w/cap set on the east right-of-way line of Santa Fe Line Road at a distance of 510.28 feet) for a total distance of 535.28 feet to a mag-nail (set) on the west line of the northwest quarter of Section 7 and the legal centerline of Santa Fe Line Road;

thence, N 00° 51′ 23″ E along the aforesaid west line and legal centerline for a distance of 437.87 feet to a monument box (found) at the northwest corner of Section 7;

thence, S 89° 08′ 44″ E along the north line of the northwest quarter of Section 7 and the legal centerline of Buckland-Holden Road for a distance of 549.56 feet to the **POINT OF BEGINNING**, containing therein 5.451 acres, of which 0.552 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per Auglaize County GPS depicting the north line of the northwest quarter of Section 7 as S 89° 08′ 44″ E. Prepared by James M.
