

The following described parcel of land is situated in the southeast quarter of Section 4, Township 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box marking the southeast corner of Section 4 also being the intersection of the centerline of Buckland-Holden Road with the centerline of Gant Road;

thence with the centerline of Gant Road N 00° 00' 00" E, a distance of 1,314.49 feet to a mag nail (set) at the POINT OF BEGINNING for the parcel to be described; thence with a new division line N 89° 56' 29" W, a distance of 220.00 feet to a 5/8 inch iron pin (set) passing at 25.00 feet a 5/8 inch iron pin (set);;

thence N 08° 14' 45" E, a distance of 569.68 feet to a 5/8 inch iron pin (set); thence N 38° 13' 21" E, a distance of 110.38 feet to a 5/8 inch iron pin (set); thence S 89° 56' 29" E, a distance of 70.00 feet to a mag nail (set) in the centerline of Gant Road passing at 45.00 feet a 5/8 inch iron pin (set);

thence with the centerline of Gant Road S 00° 00' 00" W, a distance of 650.66 feet to the POINT OF BEGINNING containing 2.526 acres, more or less, subject to all legal highways and easements of record.
