





PAT & TAVA RIDENOUR SURVEY 3.184 ACRE

The following described tract of land is part of the Northwest Quarter of Section 14, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio, being all of Parcel No. N41-014-002-00 and part of Parcel No. N41-014-002-02 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Northwest corner of the Northwest Quarter of Section 14 and in the centerline of County Road 180 (Fairmount Road);

Thence S.89°42'28"E. along the centerline of County Road 180 and the North line of the Northwest Quarter of Section 14, a distance of 1,325.35 feet to a R.R. Spike (found);

Thence S.00°53'57"W. along the centerline of Township Road 293 (Akers Road), a distance of 1,015.05 feet to a Mag Nail (set), which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.89°50'48"E. a distance of 451.17 feet to an iron pin (set), passing thru an iron pin (set) for reference at 20.00 feet in the East right-of-way line of Township Road 293;

Thence S.00°53'57"W., parallel to the centerline of Township Road 293, a distance of 307.47 feet to an iron pin (set);

Thence N.89°50'48"W. a distance of 451.17 feet to a R.R. Spike (found) in the centerline of Township Road 293, passing thru an iron pin (found) at 431.17 feet in the East right-of-way line of Township Road 293;

Thence N.00°53'57"E. along the centerline of Township Road 293 a distance of 307.47 feet, to the Mag Nail which was the true PLACE OF BEGINNING.

Containing in all 3.184 Acres of which 0.141 Acre has been used for highway purposes and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 96, Page 110. This plat is recorded in Survey Book "S", Page 51, in the Auglaize County Engineer's Office.
