SITUATE IN THE SOUTHWEST QUARTER OF SECTION 33 TOWN 7S RANGE 4E, JACKSON TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY THOMAS DIRKSEN AS RECORDED IN OFFICIAL RECORD 314, PAGE 370 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a 1 inch iron pin (found) in a monument box at the northwest corner of the southwest quarter of Section 33 and in the centerline of Minster – Egypt Road;

Thence, with the north line of the southwest quarter of Section 33 and the centerline of Minster – Egypt Road, South 88°51'48" East, 1331.57 feet to a Mag Nail (set), said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, continuing with the north line of the southwest quarter of Section 33 and the centerline of Minster – Egypt Road, South 88°51'48" East, 499.34 feet to a Mag Nail (set);

Thence, with the west line of a 50.0 acre tract of land owned by D. & E. Winner as recorded in Official Record 561 Page 2450, South 01°51'46" West, 2665.40 feet to an iron pin (set) in the south line of the south line of the southwest quarter of Section 33 and the north line of Shelby County, passing for reference at 25.00 feet an iron pin (set) in the south right of way line of Minster — Egypt Road;

Thence, with the south line of the southwest quarter of Section 33 and the north line of Shelby County, North 88°47'26" West, 498.50 feet to an iron pin (set);

Thence, with the east line of an 80.0 acre tract of land owned by C. Daughlinghaus as recorded in Official Record 644 Page 887, North 01°50'41" East, 520.05 feet to an iron pin (set);

Thence, with a new division line, South 88°09'19" East, 473.63 feet to an iron pin (set);

Thence, with a new division line, North 01°51'46" East, 1650.53 feet to an iron pin (set);

Thence, with a new division line, North 88°51'48" West, 474.18 feet to an iron pin (set);

Thence, with the east line of said 80.0 acre tract, North 01°50'41" East, 500.04 feet to the **True Point of Beginning**, passing for reference at 475.04 an iron pin (set) in the south right of way line of Minster - Egypt Road, containing 12.598 acres more or less of which 0.286 acres lie within the right of way of Minster - Egypt Road being subject to all legal rights of ways easements, agreements and restrictions of record;



Thence, with the east line of said 80.0 acre tract, North 01°50'41" East, 1644.67 feet to the **True Point of Beginning** containing 17.924 acres more or less of which 0.286 acres lie within the right of way of Minster – Egypt Road being subject to all legal rights of ways easements, agreements and restrictions of record;
