Being a part of the southwest quarter of Section 20, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio as evidenced by Official Record Volume 223, Page 915 and part of Parcel No. N4102000201 and more particularly described as follows:

Beginning at a monument box (found) at the northwest corner of the southwest quarter of Section 20 and the legal centerline of Waynesfield Road; thence, along the north line of said southwest quarter N 89° 17′ 50″ E (passing through the east right-of-way line of Waynesfield Road at a distance of 25.00 feet and passing through a 5/8″ re-rod w/cap set for reference at a distance of 30.00 feet) for a total distance of 300.00 feet to a 5/8″ re-rod w/cap (set);

thence, S $00^{\circ}~00'~00''$ W for a distance of 125.00 feet to a 5/8" re-rod w/cap (set);

thence, S 89° 17′ 50″ W (passing through a 5/8″ re-rod w/cap set for reference at a distance of 270.00 feet and the east right-of-way line of Waynesfield Road at a distance of 275.00 feet) for a total distance of 300.00 feet to a mag-nail (set) on the west line of the southwest quarter and the legal centerline of Waynesfield Road;

Being a part of the southwest quarter of Section 20, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio as evidenced by Official Record Volume 223, Page 915 and part of Parcel No. N4102000201 and all of Official Record Volume 513, Page 182 which is Parcel No. N4102000204 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northwest corner of the southwest quarter of Section 20 and the legal centerline of Waynesfield Road; thence, S 00° 00′ 00″ E along the west line of the southwest quarter and the legal centerline of Waynesfield Road for a distance of 125.00 feet to a magnail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, N 89° 17′ 50″ E (passing through the east right-of-way line of Waynesfield Road at a distance of 25.00 feet and a 5/8″ re-rod w/cap set for reference at a distance of 30.00 feet) for a total distance of 300.00 feet to a 5/8″ re-rod w/cap (set);

thence, S 00° 00′ 00″ W for a distance of 285.00 feet to a 5/8″ re-rod w/cap (set);

thence, S 89° 17′ 50″ W for a distance of 139.99 feet to a 5/8″ re-rod (found);

thence, N 00° 00′ 00″ W for a distance of 110.54 feet to a 5/8″ re-rod (found);

thence, N 90° 00′ 00″ W (passing through a 5/8″ re-rod found at a distance of 130.00 feet and the east right-of-way line of Waynesfield Road at a distance of 135.00 feet) for a total distance of 160.00 feet to a cotton gin spindle (found) on the west line of the southwest quarter and the legal centerline of Waynesfield Road;

April 14, 2015

The Wayne Township Zoning Board of Appeals met on this date to act upon the request of Anthony & Shelley Huffer, for a variance located at 16450 Waynesfield Road. Members of the Zoning Board of Appeals present were Greg Shobe, Charlie Sutherland, Tadd Turner, and Holly Turner – Zoning Clerk. Also present Auglaize County Prosecuting Attorney, Edwin Pierce and Wayne Township Trustee Erick Werling.

The meeting was called to order at 6:00 pm. Prosecuting Attorney Ed Pierce explained the procedure to be followed.

Testimony was given by Shelley Huffer and Tony Huffer. Board of Appeals members asked pertinent questions of the Huffer's.

With no further discussion Greg Shobe motioned to grant the variance of .64 acre from the required 1.5 acres, seconded by Tadd Turner.

Vote: Charlie Sutherland- no; Greg Shobe-yes; Tadd Turner-yes. Motion was passed. Variance has been approved.
