

#### DESCRIPTION

Being a parcel of land in the SW¼ of Section 2, T5S, R8E, Wayne Township, Auglaize County, Ohio, more particularly described as follows:

Commencing for reference at a set #5 rebar at the southeast corner of the SW ¼ of the SW ¼ of Section 2, thence N.00°-24'-37"E. (assumed bearing) on the east line of the SW ¼ of the SW ¼ of Section 2, (centerline of Spencer Rd), 936.78' to a set Mag nail at the POINT OF BEGINNING of the parcel to be described, thence the following courses;

- 1. S.89°-32'-46"W., 377.19' to a set #5 rebar, passing over a set #5 rebar at 20.00';
- 2. S.00°-24'-37"W., 198.25' to an existing #5 rebar;
- 3. S.89°-32'-46"W., 500.50' to a set Mag nail on the centerline of S.R. 117, passing over an existing #5 rebar at 461.52';
- 4. N.40°-07'-11"W. on the centerline of S.R. 117, 432.55' to an existing Mag nail at a P.I. on the centerline of S.R. 117;
- 5. N.40°-18'-11"W. on the centerline of S.R. 117, 246.95' to a set Mag nail at the intersection with the west line of the SW ¼ of Section 2;
- 6. N.00°-46'-31"E., 81.36' to an existing cornerstone at the northwest corner of the SW ¼ of the SW ¼ of Section 2, passing over a set #5 rebar at 45.66';
- 7. S.89°-49'-48"E. on the north line of the SW ¼ of the SW ¼, 1319.25' to an existing #5 rebar at the northeast corner of the SW ¼ of the SW ¼ of Section 2;
- 8. S.00°-24'-37"W. on the east line of the SW ¼ of the SW ¼ of Section 2 (centerline of Spencer Rd.), 391.35' to the POINT OF BEGINNING.
