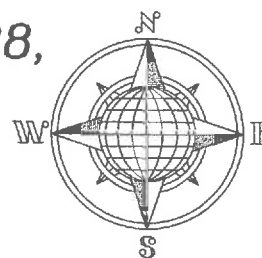
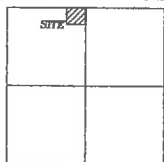


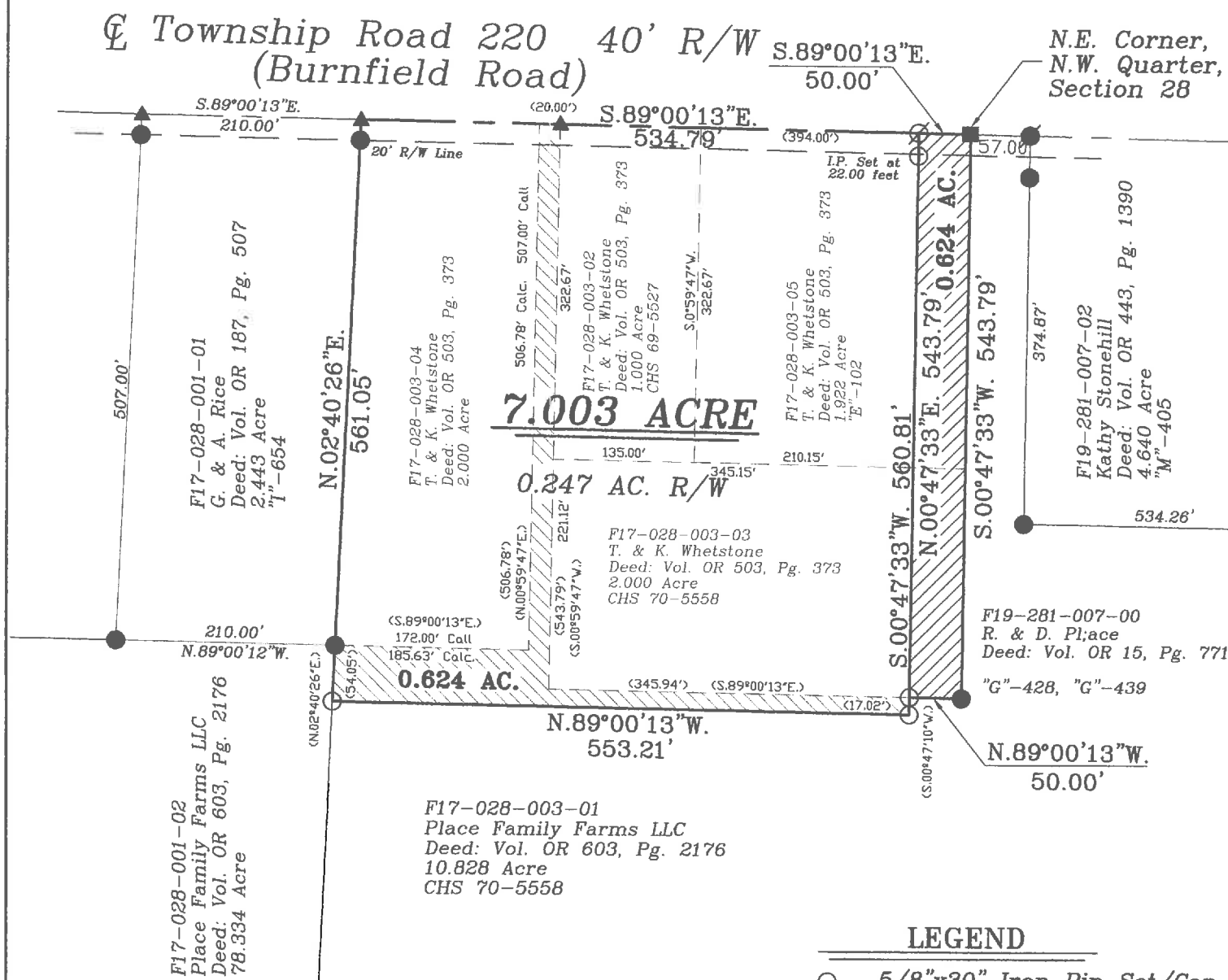

Thence S.00°47'33"W. a distance of 560.81 feet to an iron pin (set), passing thru an iron pin (set) for reference at 22.00 feet;


