

Being a part of Lot 7 & 8 and all of Lot 9 & 10 of Hager Subdivision in the northwest part of Outlot 118, City of St. Marys, Auglaize County, Ohio as evidenced by Official Record Volume 138, Page 161 and Parcel No. K3202301100 and more particularly described as follows:

BEGINNING at a 5/8" re-rod w/cap (set) at the northeast corner of Lot 10;

Thence, S 00° 00′ 25″ E along the east line of the aforesaid Lot 10 for a distance of 132.54 feet to a 5/8″ re-rod w/cap (set);

Thence, S 90° 00' 00'' W along the south line of Lot 10 & 9 for a distance of 96.34 feet to a 5/8'' re-rod w/cap (set);

Thence, N 00° 00' 00'' W along the west line of Lot 9 for a distance of 66.48 feet to a 5/8" re-rod w/cap (set);

Thence, N 89° 59′ 45″ W for a distance of 72.25 feet to a 5/8″ re-rod w/cap (set);

Thence, N 00° 00′ 25″ W for a distance of 66.48 feet to a 5/8″ re-rod w/cap (set) on the north line of Lot 7;

Thence, S 89° 51′ 31″ E along the north line of Lot 7, 8, 9 & 10 for a distance of 168.59 feet to the **POINT OF BEGINNING** containing therein 0.403 acres. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per the plat of the north part of Lot 7 prepared by Eric C. Thomas, PS 7236.
