



SURVEYOR'S DESCRIPTION

Being a part of the northwest quarter and northeast quarter of Section 8, Town-5-South, Range-7-East, Union Township, Auglaize County, Ohio as evidenced by Official Record Volume 650, Page 2216 and a part of Parcel No L33-008-007-01 and more particularly described as follows:

Commencing for reference at a monument box (found) at the center of Section 8 and the legal centerline of Miller Road; thence S 89° 48′ 12" W along the south line of the northwest guarter of Section 8 and the legal centerline of Miller Road for a distance of 375.53 feet to a cotton gin spindle (found), said spindle being the **POINT OF BEGINNING** for the tract herein described;

Thence, N 00° 41′ 15" E (passing through the north right-of-way line of Miller Road at a distance of 22.50 feet and a 5/8" re-rod w/cap found at a distance of 25.00 feet) for a total distance of 264.65 feet to a 5/8" re-rod w/cap

Thence, N 89° 48' 12" E for a distance of 411.50 feet to a 5/8" re-rod w/cap (set);

Thence, S 00° 41′ 15" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 239.69 feet and the north right-of-way line of Miller Road at a distance of 244.69 feet) for a total distance of 264.69 feet to a mag-

Thence, S 89° 52′ 30" W along the south line of the northeast guarter of Section 8 for a distance of 35.97 to a monument box (found) at the southwest corner of the northeast quarter of Section 8 and the legal centerline of Miller Road;

Thence, S 89° 48' 12" W along the south line of the northwest quarter of Section 8 and the legal centerline of Miller Road for a distance of 375.53 feet to the **POINT OF BEGINNING** containing therein 2.500 acres of which 0.218 is in the northeast quarter and 2.281 acres is in the northwest quarter and 0.212 acres is road right-of-way. Thence, N 89º 48' 12" E for a distance of 411.50 feet to a 5/8" re-rod w/cap (set);

Thence, S 00° 41' 15" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 239.69 feet and the north right-of-way line of Miller Road at a distance of 244.69 feet) for a total distance of 264.69 feet to a magnail (set);

Thence, S 89° 52′ 30" W along the south line of the northeast quarter of Section 8 for a distance of 35.97 to a monument box (found) at the southwest corner of the northeast quarter of Section 8 and the legal centerline of Miller Road;
