




Surveyor's Description

The following described parcel of land is a part of the Southeast Quarter of Section 28, Pusheta Township, Town-6-South, Range-6-East, Auglaize County, Ohio, and is further described as follows:

Being the South 52 feet off the entire South side of Lot #3 of the Brown Subdivision #1, as recorded in Plat Cabinet A, Slide 110, Auglaize County Recorder's Office, and being more particularly described as follows;

Commencing for reference at a Monument Box (found) situated at the Southeast corner of the Southeast Quarter of said Section 28, Pusheta Township;

Thence with a bearing of N. 00°-46'-00" W. along the East line of the Southeast Quarter of said Section 28, Pusheta Township, and the centerline of Cemetery Road (Township Road #161), for a distance of 281.10 feet to a Mag Nail (set) and the PLACE OF BEGINNING;

Thence with a bearing of S. 89°-00'-00" W. along the South line of Lot #3 of said Brown Subdivision #1, for a distance of 340.03 feet to a point situated at the Southwest corner of said Lot #3;

Thence with a bearing of N. 01°-00′-00″ W. along the West line of said Lot #3 for a distance of 52.00 feet to an Iron Pin (set),

Thence with a bearing of N. 89°-00'-00" E. for a distance of 340.25 feet to a Mag Nail (set), and passing thru an Iron Pin (set) for reference at a distance of 310.25 feet;

Thence with a bearing of S. 00°-46'-00" E. for a distance of 52.00 feet to a Mag Nail (set) and the original PLACE OF BEGINNING.

Containing in all 0.406 Acres of land, of which, 0.036 Acre being previously dedicated for highway purposes. The above described tract of land is subject to any or all legal easements, reservations, or restrictions of record upon said premises.
