DESCRIPTION

Being the southwest quarter of the Northeast quarter of Section 20 and that part of the west half of the Southeast quarter of Section 20 lying north of Kossuth- Amanda Road, T-4-S, R-5-E, Logan Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at the one (1) inch iron pin found in a monument box at the southwest corner of said Southeast quarter; thence N 00°56'30" W (basis of bearing-previous survey) with the west line of said Southeast quarter, 1,760.62 feet to a railroad spike found at the intersection of said west line of said Southeast quarter with the centerline of Kossuth-Amanda Road and the **PLACE OF BEGINNING** thence continuing N 00°56'30" E with said west line, 885.67 feet to an iron pipe found at the center of said Section 20; thence N 00°54'01" E with the west line of said Northeast quarter, 1,321.64 feet to the calculated northwest corner of the south half of said Northeast quarter; thence S 89°01'37" E with the north line of said south half of said Northeast quarter of said Section 20, 1,332.41 feet to a capped 5/8 inch rebar previously set at the northeast corner of the southwest quarter of said Northeast quarter; thence S 00°51'59" W with the east line of said southwest quarter of said Northeast quarter, 1,324.74 feet to the southeast corner of said southwest quarter of said Northeast quarter; thence S 00°53'12" W with the east line of the west half of said Southeast quarter of said Section 20, 292.70 feet to a PK nail previously set at the intersection of said east line with the centerline of Kossuth-Amanda Road; thence S 66°56'45" W with said centerline of Kossuth-Amanda Road, 1,448.68 feet to the **PLACE OF BEGINNING** containing 58.082 acres more or less and subject to all highways and other legal easements of record. 40.182 acres are within the southwest quarter of said Northeast quarter of said Section 20 and 17.900 acres are within in the west half of said Southeast quarter of said Section 20 lying north of Kossuth-Amanda Road. Road right-of-way occupies 0.665 acres.
