SITUATE IN THE NORTH EAST QUARTER OF SECTION 3, TOWNSHIP 7S, RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING PART OF A 16.124 ACRE TRACT OF LAND OWNED BY DEAN & SUSAN QUELLHORST RECORDED IN OFFICIAL RECORD 622 PAGE 1874 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS

Beginning for reference at a Mag Nail found at the northwest corner of the northeast quarter of Section 3, said Mag Nail also being in the centerline of Clover Four Road;

Thence, with the north line of the northeast quarter of Section 3 and the centerline of Clover Four Road, South 88°53'55" East, 478.73 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract of land herein described;

Thence, continuing with the north line of the northeast quarter of Section 3 and the centerline of Clover Four Road South 88°53'55" East, 175.00 feet to a Mag Nail found at the northwest corner of a 7.00 acre tract of land owned by Official Record 604 Page 1809;

Thence, with the west line of said 7.00 acre tract of land, South 00°19'02" West, 373.41 feet to an iron pin set, passing for reference at 20.00 feet the south right of way line of Clover Four Road, witnessing from said intersection South 53°33'37" East, 0.23 feet an iron pin with "Kremer" cap found;

Thence, with a new division line, North 88°53'55" West, 175.00 feet to an iron pin set;

Thence, with a new division line, North 00°19'02" East, 373.41 feet to the **True Point of Beginning** passing for reference at 353.41 feet an iron pin set in the south right of way line of Clover Four Road containing 1.500 acres more or less of which 0.080 acres lie within the right of way of Clover Four Road and being subject to all legal rights of ways easements, agreements and restrictions of record;

Bearings listed above are based upon NAD 83, 2011 Adj., Ohio North Zone 3401, ODOT VRS CORS Network. Pins noted as set are 5/8" x 30" rebar with pink plastic caps stamped "Lock-Two 7988". All recorded documents listed above are as recorded in the Auglaize County Recorders Office.
