

LEGAL DESCRIPTION Parcel "A"



Commencing at an existing Monument Box at the SW corner of the NE ¼ of Section 30; thence N 01°-09′-44″ E, with the W line of the NE ¼ of Section 30 (centerline of Koenig Road), 669.09′ to an existing Railroad Spike at the POINT OF BEGINNING; thence the following courses:

- 1. N 01°-09′-44″ E, continuing with said fractional section line, 230.05′ to an existing Railroad Spike;
- 2. \$ 89°-06'-33" E, 378.86' to an existing #5 Rebar, passing the right-of-way line of Koenig Road at 20.00', as referenced by an existing #5 Rebar at \$ 28°-32'-47" W, 0.21';
- 3. S 01°-10′-16" W, 230.02' to an existing #5 Rebar;
- 4. N 89°-06′-46″ W, 378.82′ to an existing Railroad Spike at the POINT OF BEGINNING, passing an existing #5 Rebar at 145.87′ and a set #5 Rebar at 358.82′.

Commencing at an existing Monument Box at the SW corner of the NE ¼ of Section 30; thence N 01°-09′-44″ E, with the W line of the NE ¼ of Section 30 (centerline of Koenig Road), 669.09′ to an existing Railroad Spike at the POINT OF BEGINNING; thence the following courses:

- 1. N 01°-09′-44″ E, continuing with said fractional section line, 230.05′ to an existing Railroad Spike;
- 2. S 89°-06′-33" E, 378.86′ to an existing #5 Rebar, passing the right-of-way line of Koenig Road at 20.00′, as referenced by an existing #5 Rebar at S 28°-32′-47" W, 0.21′;
- 3. S 01°-10'-16" W, 451.64' to a set #5 Rebar, passing an existing #5 Rebar at 230.02';
- 4. N 89°-10'-14" W, 145.75' to an existing #5 Rebar;
- 5. N 01°-08'-23" E, 221.76' to an existing #5 Rebar;

- 1. Continuing S 89°-06'-46" E, 145.87' to an existing #5 Rebar;
- 2. S 01°-10'-16" W, 221.62' to a set #5 Rebar;
- 3. N 89°-10'-14" W, 145.75' to an existing #5 Rebar;
- 4. N 01°-08'-23" E, 221.76' to the POINT OF BEGINNING.
