



SURVEYOR'S DESCRIPTION

Being a part of the northeast quarter of Section 24, Town-5-South, Range-5-East, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 503, Page 2242 and part of Parcel No. G2224100302 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the northeast quarter of Section 24 and the centerline of Infirmary Road; thence, S 89° 00' 02" E along the south line of the northeast quarter and the centerline of Infirmary Road for a distance 1003.54 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, N 00° 59' 58" E (passing through a 5/8" re-rod w/cap set on the north right-of-way line of Infirmary Road at a distance of 25.00 feet) for a total distance of 341.99 feet to a 5/8" re-rod w/cap (set);

Thence, N 83° 07' 38" W for a distance of 236.78 feet to a 5/8" re-rod w/cap (set);

Thence, N 18° 57' 46" W for a distance of 152.56 feet to a 5/8" re-rod w/cap (set);

thence, N 06° 06' 27" W for a distance of 260.82 feet to a 5/8" re-rod w/cap (set);

thence, N 23° 38' 50" E for a distance of 121.56 feet to a 5/8" re-rod w/cap (set);

thence, N 60° 22' 24" E for a distance of 115.50 feet to a 5/8" re-rod w/cap (set);

thence, S 78° 43' 48" E for a distance of 34.27 feet to a 5/8" re-rod w/cap (set);

thence, S 42° 25' 23" E for a distance of 122.26 feet to a 5/8" re-rod w/cap (set);

thence, N 88° 26' 19" E for a distance of 180.29 feet to a 5/8" re-rod w/cap (set);

thence, S 00° 51' 27" W for a distance of 403.61 feet to a 5/8" re-rod w/cap (set);

thence, N 89° 00' 02" W for a distance of 96.70 feet to a 5/8" re-rod w/cap (set);

thence, S 00° 59' 58" W (passing through a 5/8" re-rod w/cap set on the north right-of-way line of Infirmary Road at a distance of 424.00 feet) for a total distance of 449.00 feet to a mag-nail (set) on the south line of the northeast quarter and the centerline of Infirmary Road;

thence, N 89° 00' 02" W along the aforesaid south line and centerline for a distance of 28.48 feet to the **POINT OF BEGINNING**, containing therein 5.017 acres, of which 0.016 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per Auglaize County GPS depicting the south line of the northeast quarter as S 89° 00' 02" E. Prepared by James M.
