The following described parcel of land is situated in the northeast quarter of Section 24, Township 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio, being a part of parcels N4102400300, N4102400400, and N4101300400, and is more particularly described as follows:

Commencing at a monument box marking the northwest corner of the northeast quarter of Section 24 also being the centerline of State Route 67;

thence with the centerline of State Route 67, N 89° 17' 17" E, a distance of 1,168.92 feet to a mag nail (set) at the POINT OF BEGINNING for the parcel to be described;

thence continuing with said centerline N 89° 17' 17" E, a distance of 203.05 feet to a 5/8 inch re bar (found);

thence continuing with the centerline of State Route 67, N 66° 55' 17" E, a distance of 158.56 feet to a mag nail (set);

thence with a new division line S 00° 00' 00" W, a distance of 535.34 feet to a 5/8 inch re bar (set) passing at 32.61 feet a 5/8 inch re bar (set);

thence S 89° 17' 17" W, a distance of 348.93 feet to a 5/8 inch re bar (set);

thence N 00° 00' 00" E, a distance of 475.00 feet to the POINT OF BEGINNING passing at 445.00 feet a 5/8 inch re bar (set); This parcel contains 3.906 acre, more or less, subject to all legal highways and easements of record.
