
## SURVEY FOR DAVID STROH



## Surveyor's Description of 5.315 Acre Parcel

The following described parcel of land is a part of the Southeast Quarter of Section 15, St. Marys Township, Town-6-South, Range-4-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at an Iron Pin (found) situated at the Southeast corner of the Northeast Quarter of the Southeast Quarter of said Section 15, St. Marys Township, and the PLACE OF BEGINNING;

Thence with a bearing of N. 87°-51'-44" W. along the South line of the Northeast Quarter of the Southeast Quarter of said Section 15, St. Marys Township, and following the course of Koop Road, (Township Road #112), for a distance of 400.00 feet to a PK Nail (found);

Thence with a bearing of N. 02°-15'-00" E. and parallel with the East line of the Southeast Quarter of said Section 15, St. Marys Township, for a distance of 578.58 feet to an Iron Pin (found), and passing thru an Iron Pin (found) at a distance of 20.00 feet;

Thence with a bearing of S. 87°-55'-41" E. for a distance of 400.00 feet to an Iron Pin (found), and passing thru an Iron Pin (found) for reference at a distance of 312.00 feet;

Thence with a bearing of S. 02°-15'-00" W. along the East line of the Southeast Quarter of said Section 15, St. Marys Township, for a distance of 579.04 feet to an Iron Pin (found) and the original PLACE OF BEGINNING.

Containing in all 5.315 Acres of land, of which, 1.48 Acre being previously dedicated for highway purposes. The above described tract of land is subject to a previously established easement for drainage purposes, 10 feet in width, along the entire West side of the above mentioned parcel, and is also subject to any or all other legal easements, reservations, or restrictions, if any, of record upon said premises.

The basis of bearings used for this description were determined from a previous survey by James Geeslin as found in the Large Township Survey STM-15-2A and STM-15-2B, of the Auglaize County Tax Map Office.
