



## HOELSCHER FAMILY FARM, L.L.C. SURVEY PARCELS #M3602800800 & M3602800801 15.636 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 28, TOWN 6S, RANGE 5E WASHINGTON TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF THOSE LANDS OWNED BY HOELSCHER FAMILY FARM, L.L.C. AS RECORDED IN OFFICIAL RECORD 583 PAGE 34 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a P.K. nail found at the northeast corner of the northeast quarter of Section 28 and being in the intersection of the centerlines of State Route 219 and Bay Road;

Thence, with the north line of the northeast quarter of Section 28 and the centerline of State Route 219, South 89°54'40" West, 549.44 to a Mag Spike set, said Mag Spike marking the **True Point of Beginning** of the tract herein described;

Thence, with generally with the centerline of Muddy Creek the following and new division lines the following 4 courses:

- 1. South 14°18'35" East, 142.06 feet, passing at 30.95 feet the south right of way line of State Route 219, witnessing an iron pin set at South 09°30'33" West, 146.07 feet;
- 2. South 05°36'07" East, 96.44 feet, witnessing an iron pin set at South 54°47'52" West, 63.14 feet;
- 3. South 31°55'50" East, 67.64 feet, witnessing an iron pin set at North 45°40'33" West, 85.28 feet;
- 4. South 41°54'51" East, 25.63 feet, witnessing an iron pin set at North 39°35'59" West, 151.83 feet:

Thence, with new division lines the following 6 courses:

- 5. South 00°48'22" West, 931.02 feet to an iron pin set, passing for reference at 88.00 feet an iron pin set;
- 6. South 89°54'40" West, 637.73 feet to an iron pin set;
- 7. North 00°48'22" East, 466.39 feet to an iron pin set;
- 8. North 52°24'00" East, 93.74 feet to an iron pin set;
- 9. North 56°46'05" East, 62.36 feet to an iron pin set;
- 10. North 00°48'22" East, 683.74 feet to a Mag Spike set, passing for reference at 653.74 feet an iron pin set in the south right of way line of State Route 219;

Thence, with the north line of the northeast quarter of Section 28 and the centerline of State Route 219, North 89°54'40" East, 410.79 feet to the **True Point of Beginning** containing 15.636 acres more or less of which 0.286 acres lie within the right of way of State Route 219 and being subject to all legal rights of ways easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
