



## **LEGAL DESCRIPTION**

Being Parcel #N41-019-001-00 (Prior Deed Referenced in O.R. 637, Pg. 2409) and being a part of the W % of the NE % of Section 19, Town 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio, more particularly described as follows:

Beginning at an existing Monument Box at the NW corner of the NE ¼ of Section 19; thence the following courses:

- 1. S 89°-03'-59" E with the N line of the NE ¼ of Section 19 (centerline of State Route 67), 340.00' to an existing Mag Nail;
- 2. S 01°-20′-49" W, 2638.92' to a #5 Rebar set on the S line of the NE ¼ of Section 19, passing an existing #5 Rebar at 25.00';
- 3. N 89°-10′-25" W with said fractional section line, 340.00' to an existing #5 Rebar at the SW corner of the NE ¼ of Section 19;
- 4. N 01°-20'-48" E with the W line of the NE ¼ of Section 19, 2639.55' to the POINT OF BEGINNING, passing a #5 Rebar set at 2614.55'.

The above described parcel contains 20.600 acres, more or less, of which 0.234 acres are occupied by road right-of-way, subject to all legal highways and easements of record.

The system of bearings for this legal description is based on the Ohio State Plane-North Coordinate System NAD83 (2011). This legal description and accompanying plat represent an actual boundary survey completed under the direct supervision of Kyle J. Binkley, P.S. #8587 on November 22, 2016. All markers called for above are in place.
