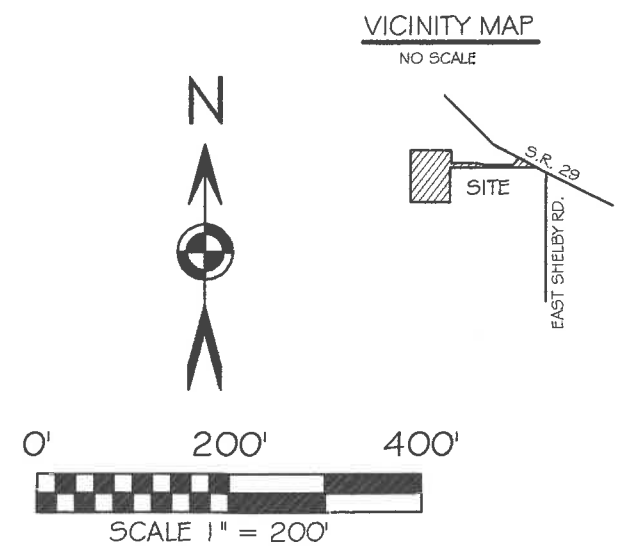
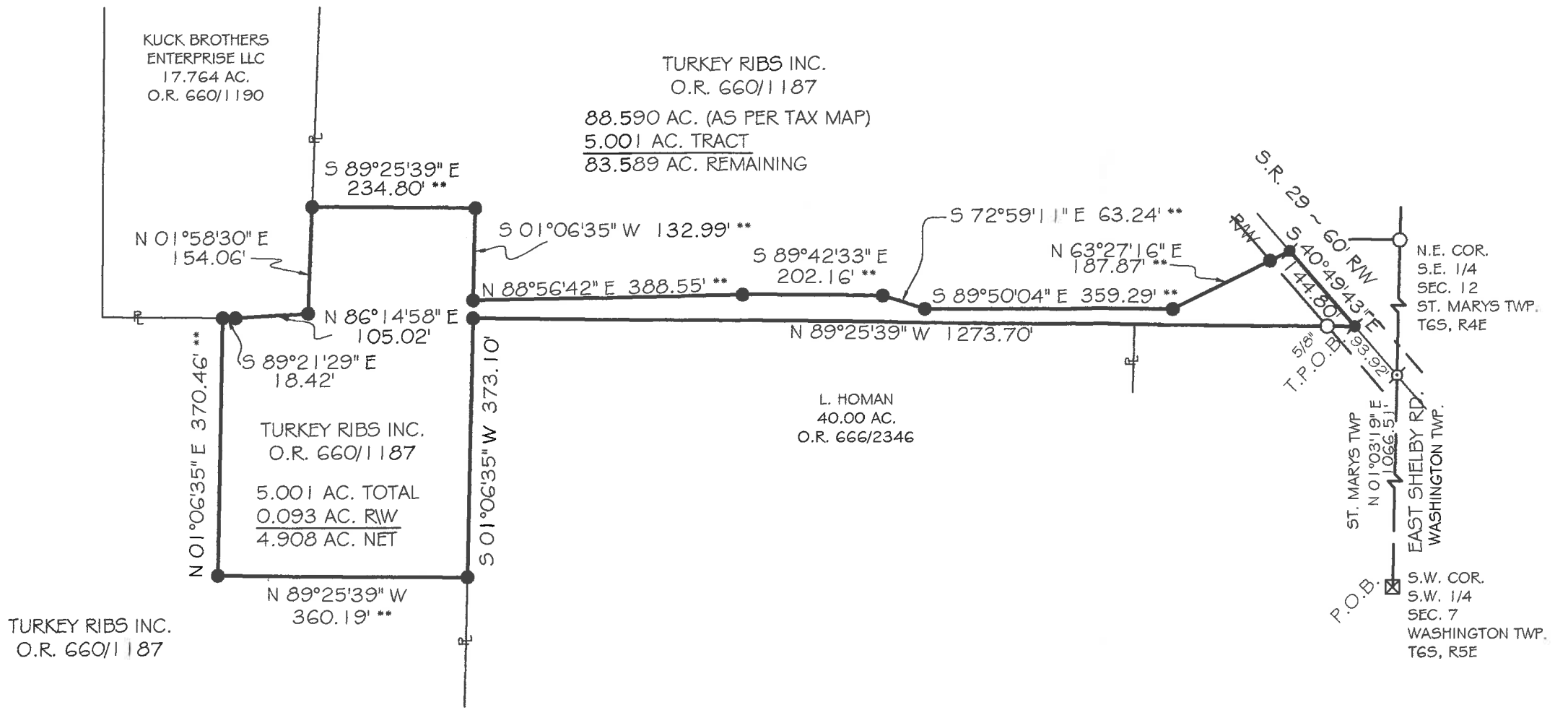

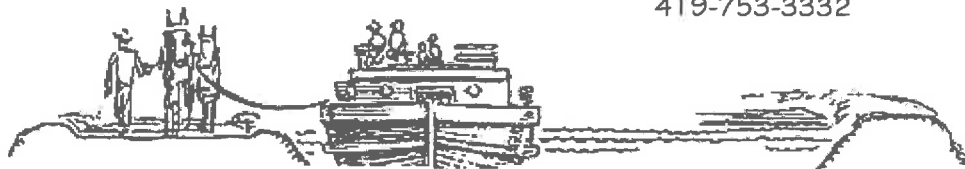

SITUATE IN THE SOUTHEAST QUARTER OF SECTION 12, TOWN 6S, RANGE 4E ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF THOSE LANDS OWNED BY TURKEY RIBS INCORPORATED AS RECORDED IN OFFICIAL RECORD 600 PAGE 1187 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at a 1 inch iron pin found at the southwest corner of the southwest quarter of Section 7 and found in the centerline of East Shelby Road;

Thence, with the west line of the southwest quarter of Section 7 and the centerline of East Shelby Road, North 01°03'19" East, 1066.51 feet to an Mag Nail found in the intersection of the centerlines of East Shelby Road and State Route 29;

Thence, with the centerline of State Route 29, North 40°49'43" West, 93.92 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with the north line of a 40.000 acre tract of land owned by L. Homan as recorded in Official Record 666 Page 2346, North 89°25'39" West, 1273.70 feet to an iron pin set, passing at 40.00 feet a 5/8 inch iron pin found in the west right of way line of State Route 29;

Thence, with the west line of said 40.000 acre tract, South 01°06'35" West, 373.10 feet to an iron pin set;

Thence, with a new division line, North 89°25'39" West, 360.19 feet to an iron pin set;

Thence, with a new division line, North 01°06'35" East, 370.46 feet to the south line of a 17.764 acre tract owned by Kuck Brother Enterprises, LLC as recorded in Official Record 660 Page 1190;

Thence, with the lines of said 17.764 acre tract the following 3 courses:

1. South 89°21'29" East, 18.42 feet to an iron pin set;
2. North 86°14'58" East, 105.02 feet to an iron pin set;
3. North 01°58'30" East, 154.06 feet to an iron pin set;

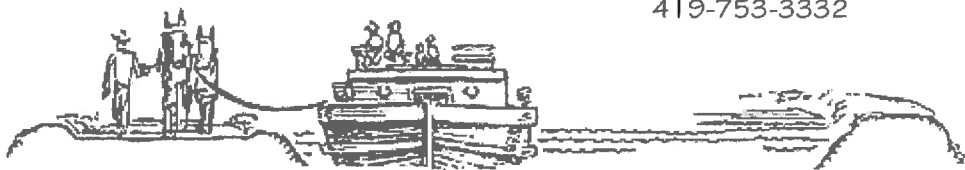
Thence, with new division lines the following 7 courses:

1. South 89°25'39" East, 234.80 feet to an iron pin set;
2. South 01°06'35" West, 132.99 feet to an iron pin set;
3. North 88°56'42" East, 388.55 feet to an iron pin set;
4. South 89°42'33" East, 202.16 feet to an iron pin set;
5. South 72°59'11" East, 63.24 feet to an iron pin set;
6. South 89°50'04" East, 359.29 feet to an iron pin set;
7. North 63°27'16" East, 187.87 feet to an Mag Nail set, passing for reference at 156.91 feet an iron pin set in the west right of way line of State Route 29;

Thence, with the centerline of State Route 29, South 40°49'43" East, 144.80 feet to the **True Point of Beginning**, containing 5.001 acres more or less of which 0.093 acres lie within the right of way of State Route 29 and being subject to all legal rights of ways easements, agreements and restrictions of record.
