SITUATE IN THE SOUTHEAST QUARTER OF SECTION 5, TOWN 6S, RANGE 4E ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, PART OF THOSE LANDS KNOWN LOTS 632 & 633 AND A PART OF VACATED CENTERWAY DRIVE, VILLA COURT SUBDIVISION, AS RECORDED IN PLAT A PAGES 85 AND 86, AND BEING OWNED BY DAVID HECKMAN & THEODORE HECKMAN AS RECORDED IN OFFICIAL RECORD 647 PAGE 441 AND BEING MORE PARTICULARY DESCRIBED AS FOLLOWS:

Beginning at an iron pin set at the southeast corner of Lot 632 and the north right of way line of Northway Drive, said iron pin also marking the **Point of Beginning** of the tract herein described;

Thence, with the south line of Lots 632 & 633 and the north right of way line of Northway Drive, North 59°58'50" West, 129.62 feet to an iron pin set in the centerline of Vacated Centerway Drive;

Thence, with the centerline of vacated Centerway Drive and the east line of those lands owned by E. Krogman as recorded in Official Record 114 Page 417, North 15°28'48" East, 80.97 feet to an iron pin set;

Thence, with a new division line, South 69°15'14" East, 125.76 feet to the west line of Lot 631, passing for reference at 123.76 feet an iron pin set;

Thence, with the west line of Lot 631 owned by B. Goubeau as recorded in Official Record 201 Page 775, South 15°20'56" West, 101.96 feet to the **Point of Beginning**, containing 0.263 acres more or less and being subject to all legal rights of ways easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
