JACK WELLMAN SURVEY 19.425 ACRE

The following described tract of land is part of the Northwest Fractional Quarter of Section 30, Town 6 South, Range 5 East, Washington Township, Auglaize County, Ohio, being part of Parcel Number M36-030-003-01 and is more particularly described as follows:

Commencing at an iron pin (found) at the Southeast corner of the Northwest Fractional Quarter of Section 30, Washington Township;

Thence N.89°23'56"W. along the South line of the Northwest Fractional Quarter of Section 30, Washington Township, a distance of 207.18 feet to an iron pin (set), which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing N.89°23'56"W. along the South line of the Northwest Fractional Quarter of Section 30, Washington Township, a distance of 1,926.73 feet to a Mag Nail (found), passing thru an iron pin (found) at 1,847.66 feet in the Southeasterly right-of-way line of County Road 65-A (New Bremen-New Knoxville Road);

Thence N.68°18'11"E. along the centerline of County Road 65-A, a distance of 124.49 feet to a Mag Nail (found) which is the P.C. of a curve to the left having the following curve data: $\triangle = 21^{\circ}15'30$ ", R = 572.80 feet, LA = 212.53 feet;

Thence along the chord of a curve to the left which bears N.57°40'43"E., a distance of 211.22 feet to a Mag Nail (found) being the P.T of said curve;

Thence N.47°03'15"E. along the centerline of County Road 65-A, a distance of 514.89 feet to a Mag Nail (found);

Thence S.42°56'45"E. a distance of 467.16 feet to an iron pin with cap (set), passing thru an iron pin with cap (found) at 25.00 feet in the Southeasterly right-of-way line of County Road 65-A;

Thence N.47°03'15"E., parallel to the centerline of County Road 65-A, a distance of 467.16 feet to an iron pin with cap (set);

Thence N.42°56'45"W. a distance of 467.16 feet to a Mag Nail (found) in the centerline of County Road 65-A, passing thru an iron pin with cap (found) at 437.16 feet in the Southeasterly right-of-way line of said County Road 65-A;

Thence N.47°03'15"E. along the centerline of County Road 65-A, a distance of 560.57 feet to a Mag Nail (found);

Thence S.08°12'44"E. a distance of 765.97 feet to an iron pin with cap (set); Thence S.89°39'03"E. a distance of 326.00 feet to an iron pin with cap (set); Thence S.08°12'44"E. a distance of 474.94 feet to the iron pin with cap (set), which was the true PLACE OF BEGINNING.

Containing in all 19.425 Acre of which 0.944 Acre being road right-of-way. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR483, page 911. The above description and plat are recorded in Survey Book "S", Page 675, in the Auglaize County Engineer's Office. Basis of bearing is holding the centerline of County Road 65-A as N.47°03'15"E. based on Ohio State Plane-North Coordinate System NAD83 (2011).
