Commencing at a monument box marking the northwest corner of the northwest quarter of Section 4 also being the centerline of Allen-Union-Wayne Road;

thence with the centerline of Allen-Union-Wayne Road, N 89° 18' 00" E, a distance of 176.91 feet to a mag nail (set) at the POINT OF BEGINNING for the parcel to be described;

thence continuing with said centerline, N 89° 18' 00" E, a distance of 321.90 feet to a mag nail (found)

thence S 00° 07' 41" W, a distance of 880.00 feet to a 5/8 inch re bar (found) passing at 20.00 feet a 5/8 inch re bar (found);

thence S 89° 18' 00" W, a distance of 498.81 feet to a 5/8 inch re bar (found) in the west line of the northwest quarter of Section 4;

thence S 89° 49' 49" W, a distance of 183.20 feet to a 5/8 inch re bar (found);

thence N 00° 07' 41" E, a distance of 483.54 feet to a 5/8 inch re bar (set);

thence N 85° 13' 14" E, a distance of 374.48 feet to a 5/8 inch re bar (set);

thence N 01° 53′ 53″ W, a distance of 368.16 feet to the POINT OF BEGINNING passing at 348.16 feet a 5/8 inch re bar (set). Beginning at a monument box marking the northwest corner of the northwest quarter of Section 4 also being the centerline of Allen – Union – Wayne Road;

thence with the centerline of Allen – Union – Wayne Road N 89° 18' 00" E, a distance of 176.91 feet to a mag nail (set);

thence S 01° 53' 53" E, a distance of 368.16 feet to a 5/8 inch re bar (set) passing at 20.00 feet a 5/8 inch re bar (set);

thence S 85° 13' 14" W, a distance of 374.48 feet to a 5/8 inch re bar (set); thence N 00° 07' 41" E, a distance of 396.46 feet to a mag nail (found) in the centerline of Allen –Union –Wayne Road passing at 376.46 feet a 5/8 inch re bar (found);
