Thence continuing South 89°32'49" West along said South line (Santa Fe – New Knoxville Road) a distance of 126.50 feet to a Mag nail set;

Thence along a new division the following three (3) courses:

North 00°54'38" East a distance of 374.53 feet to a 5/8 inch rebar with ID cap set and passing a 5/8 inch rebar with ID cap set at 30.00 feet;

North 89°23'55" East a distance of 126.51 feet to a 5/8 inch rebar with ID cap set;

South 00°54'38" West a distance of 374.86 feet to the POINT OF BEGINNING, passing a 5/8 inch rebar with ID cap set at 344.86 feet, said tract containing 1.088 acres of land, more or less, of which 0.087 acres lies within the right-of-way of Santa Fe – New Knoxville Road. This tract coming out of Parcel No. I24-241-002-00.
