
## VILLAGE OF MINSTER WATER TOWER TRACT SPLIT

SITUATE IN SOUTHEAST QUARTER OF SECTION 34, T 7 S, R 4 E, VILLAGE OF MINSTER, JACKSON TOWNSHIP, AUGLAIZE COUNTY, OHIO



## **LEGAL DESCRIPTION**

BEING A PART OF PARCEL NUMBER E1502801200, A 1.704-ACRE TRACT OF LAND OWNED BY THE VILALGE OF MINSTER AS DESCRIBED IN OFFICIAL RECORD 104, PAGE 561 OF THE AUGLAIZE COUNTY DEED RECORDS, SITUATE IN THE SOUTHEAST QUARTER OF SECTION 34, TOWN 7 SOUTH, RANGE 4 EAST, JACKSON TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

Commencing for reference at the northeast corner of the southeast quarter of Section 34 and being on the centerline State Route 66;

thence, North 89°-06'-46" West, 1320.41 feet, along the north line of the southeast quarter section to a point at the northwest corner of a tract of land owned by Minster Cemetery as described in Deed Book 47, Page 590 and the northeast corner of a tract of land owned by Joseph L. Bernardin, Trustee as described in Deed Book 230, Page 455;

thence, South 01°-43'-30" West, 1031.27 feet, along the west line of said Minster Cemetery tract and the east line of said Joseph L. Bernardin, Trustee and it's extension to an iron pin with cap set on the east line of a 4.896-acre tract of land owned by Village of Minster as described in Deed Book 230, Page 457 and being the principal place of beginning of the tract herein described;

thence, South 89°-03'-45" East, 199.87 feet, along a new division line to an iron pin with cap set on the west line of a 17.552-acre tract of land owned by Dale A. Meyer as described in Official Record 671, Page 2543;

thence, South 01°-45'-11" West, 76.00 feet, along the west line of said Meyer tract to an iron pin with cap set on the north line of a tract of land owned by The Dannon Company, Inc. as described in Official Record 553, Page 225;

thence, North 89°-03'-45" West, 199.83 feet, along the north line of said The Dannon Company to an iron pin found on the east line of a 1.804-acre tract of land owned by the Village of Minster as described in Official Record 459, Page 2198,

thence, North 01°-43'-30" East, 76.00 feet, along the east line of said 1.804-acre Village of Minster tract and it's extension to the principal place of beginning.

Containing 0.349 acres more or less and all being subject to any legal highways and easements of record. The bearings are assumed and used to denote angles only.
