thence with the centerline of Cemetery Road, S 01° 13' 24" W, a distance of 425.71 feet to a railroad spike (found) at the POINT OF BEGINNING for the parcel to be described:

thence continuing with said centerline S 01° 13' 24" W, a distance of 390.79 feet to a mag nail (found);

thence N 89° 47' 13" W, a distance of 486.00 feet to a 5/8 inch re bar (found) passing at 25.00 feet a 5/8 inch re bar (found);

thence S 01° 13' 24" W, a distance of 512.00 feet to a 5/8 inch re bar (found); thence N 89° 47' 13" W, a distance of 1,169.35 feet to a point in the west LA right of way line of I-75 passing at 919.35 feet a 5/8 inch re bar (set);
